Tour visit report of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes (NCST), New Delhi to Prohibition and Excise Department and Beverages Corporation Hyderabad to review the implementation of Constitutional Safeguards, Welfare and Development Schemes for Scheduled Tribes from 28th August, 2024(10.00 AM)

The National Commission for Scheduled Tribes (NCST) is a constitutional body set up under Article 338A of the Constitution of India to investigate and monitor all matter relating to protection, welfare and socio-economic development of Scheduled Tribes in the country. As per constitutional provisions, the Union and every State Govt. shall consult the Commission on all major policy of decisions affecting Scheduled Tribes. The Commission is required to present to the Hon'ble President of India reports upon working of those safeguards and all such reports are to be laid before each House of Parliament along with Memorandum explaining the Action Taken or propose to be taken on the recommendations relating to the Union and the reasons for non-acceptance, if any, of any of such recommendations.

In pursuance of the above constitutional mandate, Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes accompanied by Shri Ashok Lakkarasu, PS to Hon'ble Member (JH) visited Prohibition and Excise Department, Telangana and Beverages Corporation, Telangana and met with local ST Associations and officers with a view to understand the issues faced by them in order to evaluate the working of constitutional safeguards available to the Scheduled Tribes in Prohibition and Excise Department and review implementation of various constitutional safeguards and other developmental schemes/programmes for the welfare and development of Scheduled Tribes.

- 4. The following are the general observations made by the Hon'ble member
 - Separate Scheduled Tribes Cell may be created if not separated from the combined SC/ST Association along with a Liaison officer exclusively for pursuing the ST related grievances.
 - 2. Monthly grievance day for all associations-SC,ST, OBC and others and quarterly meetings with all associations to follow-up the status of their grievances.
 - 3. The ST Employees Association may be provided with the necessary facilities for the Association meetings held periodically from time to time. If possible a Community Hall Should be built for Scheduled Tribes Employees and maintenance may be made.
 - 4. Permitting for official celebration of World Tribal day on August 9th and Janjatiya Gaurav Diwas on 15th November, Sevalal Jayanthi on 15th February, Ambedkar Jayanthi on April 14th.
 - 5. ST employees should be given opportunity for higher studies under GO MS No.342.
 - Rule of Reservation needs to be followed for Contract jobs, Outsourcing jobs and Casual Jobs. The details of STs Employees in Contract jobs, Outsourcing jobs and Casual Jobs shall be furnished.
 - 7. Rule of Reservation (RoR) and Roster in employment shall be strictly followed.
 - 8. ST Backlog posts shall be filled immediately and local STs shall be given priority in Contract and outsourcing jobs.
 - 9. Employment Notifications shall be proactively intimated to the ST and other Associations.
 - 10. Any Policy decision taken in the organization shall be intimated to all the employee associations.

- 5. Certain information is sought by the Commissions under
 - As per your reservation policy for allotment of shops it is 5% for STs, 10% for SCs and 15% for Gouds(BC). Is it being followed?.
 - 2. Is the 5% reservations of shops for STs inclusive or exclusive of the allocations made in the agency areas.
 - 3. Is 100% allocation of shops made in Ageny areas as per the PESA Act?
 - 4. Number of Cases booked on STs as part of illicit liquor sale and bind overs made and the amount collected from Scheduled Tribes as penality under breach of Bond
 - 5. STs supported under Gudumba Rehabilitation scheme
 - 6. Whether Slabs of the Bar license and corresponding Rules and regulations are followed or not
 - 7. Details of TCS TFT Licenses given to STs and those present in Thandas.
 - 8. Steps taken on Belt shops and Benami Toddy shops and action taken.

6. Specific Grievances brought to the notice of the commission with regard to the service matters are as under

- Roster system is not followed and promotions are pending. No updation of service matters.
- 2. The issue of Shri Nandu singh, Head constable whose promotion is pending from 13 years to be resolved
- 3. Details of Adequacy clause as per GO Ms. No 5 to be furnished.
- 4. Seniority issues in promotions in 5th and 6th Zones. Though in 6th Zone inspectors were promoted as Excise Superintendents in 5th Zone they still remained as Inspectors.
- 5. Certain Anamolies reported in the seniority fixation in APES and other cadres to be addressed.
- Shri Rajendar belonging of Rajanna Siricilla District whose issue of promotion from Constable to Head Constable is pending to be resolved for want of Nodal clarity
- 7. Issue of service matters relating to Shri Praveen Naik, Office superintendent.
- 8. TGBCL 2018 Batch employees were denied promotion even after 3 years inspite of heaving clear vacancy position.
- 9. Disparity between the promotional issues of Uniform services and Ministerial staff.
- 7. The Commission desires that the Prohibition ad Excise Department should dispose off the grievances highlighted by the in a time bound manner. The NCST will continue to monitor the situation and provide support Prohibition ad Excise Department administration in addressing these challenges.
