A representation dated 02.01.2024 of Smt M. Meena Kumari, W/o Shri G Ramesh, House No. MIG-12, Vuda Colony, Phase-IV, Near Kavitha Restaurent and Bar, Contonment, Vizianagaram was received in the Commission, Wherein it was stated that she is working as Secondary Grade Teacher at MPP School, S. Jagaram Village, Vizianagaram (AP) and alleged that she and her father given a loan of Rs. 6 lakhs on 09.07.2020 and Rs. 7 lakhs on 16.07.2022 to Shri K. Jaganadham Naidu, who is also a teacher in same school. He assured that he will return the money within 06 months. After 06 months she asked the money and he replied that he had no money and would give it whenever he had it. On 22.04.2023 she again went to K. Jaganadham Naidu's house and asked him to give the money, immediately he got up in anger and grabbed her hair and pushed out the house and insulted with caste based languages. She complained against Shri K. Jorganadham Naidu at Chinamerengi Village Police Station, Kurupain Mandal, Parvathipuram Manyam District. But no case has been registered. She requested the Commission to intervene in the matter.

2. Commission issued Notice to the Superintendent of Police, District-Vizianagaram, Andhra Pradesh and Superintendent of Police, District Parvathipuram Manyam, Andhra Pradesh on dated 04/01/2024 for ATR/Reply within 15 days.



4. The Deputy Superintendent of Police, District- Parvathipuram Manyam, Andhra Pradesh and SI were present on the hearing. The petitioner Smt. M. Meena Kumari was also present in the hearing.

5. The matter was examined in detail. The Superintendent of Police, District-Parvathipuram Manyam, Andhra Pradesh presented comprehensive details of the case before the Commission.

6. After hearing the matter, the Commission recommends that:

- Concerned DSP Sh. Krishna Rao, CI Sh. Prasad Rao and SI Sh. Hanish, related to the incident should be present before the Commission in the next hearing.
- Summon may be issued to Superintendent of Police, Distt.- Vizianagaram, Andhra Pradesh.
