Minutes of the Sitting chaired By Shri Jatothu Hussain, Hon'ble Member, NCST on 08.07.2024 in the complaint filed by Shri Sabavat Srinivas Naik,,3-14, Singannaguda Tanda,Rajapur Mandal, Mahabubnagar District, Telangana

A representation dated 29.11.2023 from Shri Sabavat Srinivas Naik,3-14, Singannaguda Tanda,Rajapur Mandal, Mahabubnagar District, Telangana was received in the Commission, wherein it was stated that he is a National President of Sevalal Sena and belongs to ST community, he does good work for ST people. because of that some people of upper caste threatened him, filed false cases against him and on 17th November,2023 there was a murder attempt on him by tipper. Shadnagar Police station didn't even take any action on his complaint, they are just delaying the action in the name of election. There are involvement of few upper caste persons and in this murder attempt, there is involvement of Mahendar and CI Jamalappa. CI Jamalappa involved with Political leaders and business persons. They harassed petitioner physically and mentally abused him many times in the name of caste. Mahendar and CI Jamalappa are picturizing murder attempt as a fight between petitioner and Sabavath Balu so that they can get easy escape from the case. Petitioner further stated that Some Police personnel tried very hard till date to help Mahendar, CI Jamalappa and others in the case. These accused may attack on him again. Petitioner requested the Commission to intervene in the matter and give direction to the concerned authority.

2. The Commission sent Notice to the Commissioner of Police, Cyberabad, Government of Telangana vide Notice dated 03.01.2024 for ATR/Reply within 15 days in the Commission.

3. In response to NCST notice dated 03.01.2024, No reply was received in the Commission. The Commission fixed a Sitting on 08.07.2024 with the Commissioner of Police, Cyberabad, Telangana.

4. On behalf of the Commissioner of Police, Cyberabad, Deputy Commissioner of Police, Shamshabad and Asstt. Commissioner of Police, Shadnagar were present in the Sitting. The petitioner Shri Sabavat Srinivas Naik was not present in the Sitting.

5. The matter was examined in detail. The Deputy Commissioner of Police, Shamshabad presented details of the case before the Commission. He informed that the petitioner is rowdy-sheeter, there are 16 cases registered against him. He also informed that petitioner is a habitual offender.

6. After hearing the matter, the Commission recommends that:

- No Action is required as per submission of reply by the authority, Hence complaint is closed.
