Minutes of the Sitting chaired By Shri Jatothu Hussain, Hon'ble Member, NCST on 28.06.2024 in the case Ms. Sujatha Eslavath, President- Banjara Mahila Society, 18 - 1516/3, Kakatiya Nagar, Railway Station Road, Hyderabad, Telangana regarding suspicious murder of Dharavath Nikhil, R/o Suryapet.

A representation dated 27.10.2022 was received in the NCST Representation received from Ms. Sujatha Eslavath, W/o China Gopal Eslavath, President- Banjara Mahila Society, 18- 1516/3, Kakatiya Nagar, Railway Station Road, Hyderabad, Telangana regarding the suspicious murder of Dharavath Nikhil, R/o Suryapet. The petitioner stated that Dharavath Nikhil belonging to the Scheduled Tribe was found dead in a suspicious way on 11.10.2022. The petitioner also stated that the family member of the deceased informed that he had a relationship with a girl who belonged to a upper caste. There were several injuries on the dead body of the victim which indicated physical assault. The family members of the deceased informed that this is a honor killing and have filed an FIR vide no. 124 of 2022 dated 11-10-2022 under Section 174 - IPC. No action has been taken by the police yet.

- 2. Commission issued Notice to the Director General of Police, Telangana State and the Superintendent of Police, District– Suryapet vide Notice dated 07.11.2022 for ATR/Reply within 7 days.
- 3. In response to NCST notice dated 07.11.2022, a reply dated 21.11.2022 was received from the Superintendent of Police, Suryapet, wherein it was stated that the case is under investigation. Presently the case is pending with the CID, Nalgonda. In this matter, the Commission fixed a Hearing on 28.06.2024 with the Director General of Police, Superintendent of Police and the petitioner.
- 4. The Add. Superintendent of Police, CID, Cyberabad was present in the hearing. The petitioner Ms. Sujatha Eslavath, sister and father of the deceased were also present in the hearing.
- 5. The matter was examined in detail. The Add. Superintendent of Police, CID, Cyberabad presented details of the case before the Commission.

- Another hearing will be held in August, 2024 to monitor the progress of investigation.
- Reinvestigate the case and conduct enquiry with all the persons including the girl, alongwith lie detection test who was mentioned by the family members of the deceased.
- File the case under SC/ST (POA) Act with appropriate sections in view of the death of victim.
- Police Protection may be provided to the Petitioner and the family members of the deceased.
