

A representation dated 12/08/2021 of Smt. Rupam Kirti, Sarojini Villa, House No-1, Jogo Pahar, Adalhatu Road, Ranchi, Jharkhand was received in the Commission, wherein she stated that due to bad marriage followed by divorce in the year 2018, she moved to Hyderabad in the year 2019 and joined the RIRCM Global Private Limited company. The petitioner with intention to find a life partner and companion, she met the person named Mr. Shailendra Veguru S/O Shri V. Vijaya Kumar, that is the accused. After few initial talk and chat, where the accused came to know that the she is a single woman and earning handsome salary and perks, he started influencing her with his sugar-coated words and gained the confidence of her. In all the conversations and talks the accused made her believe that he really cares for her emotionally and is very supportive, loyal, sympathetic, kind and understanding. The accused cunningly and cleverly created an environment where she became a prey and got trapped in the fraudulent and deceitful web created by the accused. The petitioner complained that the accused has exploited he both physically and mentally. In this regard she has made a police complaint against accused but no action was taken by the concerned police authorities. She requested the action against the accused. Petitioner requested the Commission to intervene in the matter.

2. The Commission sent Notice to the Director General of Police, Telangana Police and Commissioner of Police, Hyderabad City on dated 21/10/2021 for ATR/Reply within 30 days.

On behalf of The Director General of Police, Telangana Police and Commissioner of Police, Hyderabad City, DCP, Madhapur and ACP, Miyapur was present. The petitioner Smt. Rupam Kirti was also present in the hearing.

5. The matter was examined in detail. The Deputy Commissioner of Police, Madhapur presented details of the case before the Commission. The petitioner Smt. Rupam Kirti informed that she has taken her complaint back from Police Station.

6. After hearing the matter, the Commission recommends:

- To close the case as the petitioner has taken her case back.
