Minutes of the meeting held under the Chairmanship of Shri Nirupam Chakma, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi regarding delay in promotion by MTNL in the case of Shri huttan Lal Meena and others, Senior Manager (Telecom), MTNL, New Delhi.

Shrichhuttan Lal Meena, Senior Manager (Telecom), MTNL, New Delhi, and others vide his representation dated 07/07/2023 has stated that MTNL is not promoting them from Senior Manager to Deputy General Manager despite available vacancies.

2. NCST vide notice dated 01.08.2023 had referred the matter to CMD, MTNL for furnishing the facts and comments. MTNL, New Delhi vide letter dated 18.12.2023 has furnished the facts and comments and stated that the financial position of MTNL is under tremendous strain and future is uncertain. The petitioners have been given financial upgradation and no financial loss is occurring. Since the petitioners were not satisfied with the reply, the Commission held a sitting with CMD, MTNL and the petitioners on 09.02.2024 to resolve the issues. In the sitting held on 09.02.2024, the Commission recommended that —

"After discussion with the CMD, the Commission recommends that MTNL may furnish their brief on status of the case in the light of submissions made to the Committee of Secretaries and Group of Ministers as assured by the CMD in the meeting. It is also suggested that an Internal Grievance Committee for resolving the problems of STs of DAE may be constituted as advised by NCST in August 2021 to Ministries/Departments."

- 3. The minutes were forwarded to MTNL and petitioners vide NCST letter dated 26.52.2024. MTNL vide letter dated 21.02.2024 and 22.03.2024 reiterated their earlier reply in which no information regarding decision of Committee of Secretaries or Group of Ministers was given.
- 4. The Commission again decided to discuss the issue with the CMD, MINL and the petitioners on 25.09.2024 which was communicated vide NCST letter dated 12.09.2024.
- 5. In the sitting, the Director, HR, MTNL was present on behalf of CMD, MINL. The petitioners were also present. MTNL officials reiterated their earlier reply and further informed that no decision had been taken regarding the future of MTNL yet. MTNL officials informed the Commission that no promotions had been given to any employee since 2019 and everyone was affected.

After discussions with both the parties, the Commission recommends the following: -

- (1)The order/decision/circular by which the decision to stop promotions across all cadres was taken may be provided within 15 days from the date of receipt of the minutes.
- (2) Information regarding the decision of Committee of Secretaries/Group of Ministers, whenever a final decision is taken, may be submitted to the Commission.
