Minutes of the meeting held under the Chairmanship of Shri Nirupam Chakma, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi regarding denial of promotion and transfer at fag end of career in the case of Shri Sukhlal Birua, Chief Workshop Engineer, North East Frontier Railways.

Shri Sukhlal Birua, Chief Workshop Engineer, North East Frontier Railways, Guwahati, Assam vide his representation dated 02.06.2024 alleged that he was deprived from occupying the post of Principal Chief Mechanical Engineer and was transferred in remaining six months of retirement (due on 30.11.2024). He was deprived from heading the Mechanical Department of North East Frontier Railway (NFR) and the post of Principal Chief Mechanical Officer (HAG level) was given to a junior officer (non-HAG level) who was posted there.

- 2. NCST vide notice dated 02.07.2024 had referred the matter to Chairperson and Chief Executive Office, Railway Board, New Delhi for furnishing facts and comments within 15 days. Reply was not received from Railway Board, a reminder letter was sent on 26.07.2024 for submitting the information within 3 days.
- 3. The Railway Board, vide their letter no. E(O)III-2024/CL/52 dated 08.08.2024 informed that the transfer of Shri Sukhlal Birua has been cancelled and he has been retained in N.F. Railways and posted as CAO/Proj on NFR on 30.07.2024. It further stated that posting on a particular post is an administrative decision and no officer can claim for posting on a particular post.
- 4. NCST decided to discuss the issue with the Chairman and CEO, Railway Board and the petitioner on 09.10.2024. Accordingly, Sitting Notice was sent by NCST letter dated 30.09.2024 to concerned authority and petitioner.
- 5. The Chairman and CEO, Railway Board vide letter dated 08.10.2024 sought exemption and deputed Additional Member (Mech. Engineering) and Joint Secretary (Gaz.), Railway Board. The concerned officers and the petitioner were present.
- 6. The petitioner reiterated his earlier submissions and stated that he had been posted as Chief Administrative Officer (CAO) at present and is due to retire on 30.11.2024. Officers of Railway Board informed the Commission that transfer of the petitioner had been done due to administrative reasons and the Principal Chief Mechanical Engineer and CAO posts are of Level-15 and reporting directly to General Manager, NF Railway.
- 7. The Commission observed that the transfer of the petitioner who is going to retire on 30.11.2024 was done so that PCME post could be given to a junior. There was nothing against the petitioner due to which authority had taken such action. Prima facie action taken by concerned authority to be discriminatory. Since less than 2 month are left for the petitioner's retirement, Railway Board needs to take corrective action expeditiously. Officers of Railway Board assured the Commission that they will sort out the matter within 10 days (by 21.10.2024).

- After hearing both the sides, the Commission recommends the following and suggested to submit the Action Taken Report to Commission by 21.10.2024 from the receipt of the minutes:
 - 1. Relevant portion of the notes by which petitioner was transferred from NFR to CAMTECH, Gwalior, may be provided.
 - 2. The post of PCME may be restored in favour of petitioner so that he can retire with dignity and honor on 30.11.2024.
