

Minutes of the meeting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, regarding delay in promotion of Shri N.L. Meena, TO/E, Electrical Section, Heavy Water Plant, Kota.

Shri N.L. Meena, TO/E, Electrical Section, Heavy Water Plant, Kota has forwarded a copy of his rejoinder dated 08.04.2020 in response to reply of D/o Atomic Energy letter dated 12.02.2020. The petitioner alleged that his promotion was delayed by 10 years due to which his colleagues became senior to him.

In the sitting held on 09.02.2024 the Commission observed the following: "The Commission observed that the explanation provided by Department of Atomic Energy is as per the existing rules/regulations. Therefore, there is no further action warranted on part of NCST. However it is suggested that an Internal Grievance Committee for resolving the problems of STs of DAE may be constituted as advised by NCST in August 2021 to Ministries/Departments."

Petitioner vide his letter dated 17.06.2024 and 05.07.2024 stated that he was not satisfied with the resolution of the case and requested for another sitting. The Commission decided to again discuss the issue with the authority and the petitioner on 16.10.2024. Accordingly, a Sitting Notice was sent to concerned authority and petitioner vide NCST Notice dated 07.10.2024.

Secretary, DAE and other senior officers of DAE and the petitioner were present in Sitting. Petitioner reiterated his previous submissions. The officials of DAE submitted their earlier reply and stated that there was no discrimination against the petitioner.

After hearing both the sides, the Commission found no discrimination or violation of rules on part DAE, however, as per submission of petitioner, it is recommended that the case may be re-examined.
