**Proceedings of the Sitting held on 28.01.2015 in the Regional
office of the Commission at Ranchi.**

In Chair : Dr. Rameshwar Oraon, Chairperson, NCST

In attendance :

- (a) **District Authorities:** Dy. Commissioner, Latehar could not attend and Shri Anil Kumar, ADM did not report in time.
- (b) **Petitioner:** Shri Lalu Oraon, P.S.-Chandwa, Dist.-Latehar, Jharkhand

Matter : Petition of Shri Lalu Oraon for providing compensation and employment for acquisition of his Land.

1. Sitting in the matter was earlier held on 31.01.2013 wherein Dy. Commissioner, Latehar was asked to enquire into the matter and send report on it. However, report was not received by the Commission. Therefore, in pursuance of matter, Commission's vide its letter dated 15/01/2015, asked to Dy. Commissioner, Latehar to furnish the information/report on the points mentioned above letter, failing which, Sitting would be held at Ranchi with Dy. Commissioner, Latehar.

2. Due to non receipt of reply/information, a Sitting was scheduled at NCST Ranchi Regional Office on 28/01/2015 for personal appearance of Dy. Commissioner, Latehar. However, Shri Anil Kumar, ADM, Latehar was deputed by the Dy. Commissioner, Latehar to attend the Scheduled Sitting on 28.01.2015 at 11.00Hrs. at NCST, Regional Office Ranchi, to discuss on the complaint of Shri Lalu Oraon. Shri Anil Kumar did not report in time at NCST Regional Office, Ranchi. Therefore, Sitting could not be held.


3. Hon'ble Chairperson expressed his displeasure in the manner in which District Administration was handling the matter. Hon'ble Chairperson directed that Dy. Commissioner Latehar should submit the report on the points mentioned in the letter dated 15/01/2015 of the Commission within 15 days from the date of issue of this proceedings.
