It is therefore requested you to kindly make it convenient to attend the Sitting in Commission on the scheduled date and time with following documents/records in original in the case -:

1. Board Proceedings of DPC held on 24/11/1992 for promotion of BSF officers from Assistant Commandant to Deputy Commandant.
2. Gradation list of BSF Group 'A' officers (Assistant Commandant only) of the year 1992 i.e. before DPC.
3. Gradation list of BSF Group 'A' officers (Deputy Commandant only) of the year 1994 i.e. after DPC.
4. Promotion order of Deputy Commandant issued on 13/02/1993.

It is also advised that the petitioner Shri Chuni Lal Belwa may also be informed to attend the scheduled sitting at the date and time.
