Sub: Review of Constitutional Safeguards for Scheduled Tribes.

Sir,

The National Commission for Scheduled Tribes (NCST) has been set up under Article 338A of the Constitution of India vested with responsibility, inter-alia to investigate and monitor all matters relating to the safeguards provided to the Scheduled Tribes under the Constitution or under any other law for the time being in force or under any order of the Government and to monitor and evaluate the working of such safeguards. The NCST is required to present to the Hon'ble President of India, annually and at such other times as the Commission may deem fit, reports upon the working of those safeguards.

2. Accordingly, the NCST has decided to review the implementation of Constitutional safeguards including reservation policy in respect of your District. The NCST has evolved a questionnaire for review, a copy of the same is enclosed for furnishing replies / information by your District. A copy of the Questionnaire is available in the NCST's website. <https://ncst.nic.in/content/questionnaire-review-welfare-sts-district-authorities>. The replies to various issues covered under the questionnaire will form the basis for review meeting.

3. It is requested that replies / information in respect of questionnaire may be prepared and furnished to this Commission by **14th June, 2019**. A soft copy of the replies to the questionnaire may also be sent to js@ncst.nic.in for record. A brief presentation along with measures / programmes taken up by the Govt. of Himachal Pradesh for welfare of Scheduled Tribes in the District may also be made during the review meeting before the Commission.

4. The Commission is visiting State of Himachal Pradesh from 19.06.2019 to 23.06.2019, this has been communicated by the NCST vide wireless message No. Review/17/2019/Himachal Pradesh/RU-I dated 07.06.2019. The Review Meeting will be held on 20.06.2019 at 0900 Hrs at Keylong.
