The National Commission for Scheduled Tribes (NCST) set up under Article 338A of the Constitution is vested with responsibility inter-alia, to investigate and monitor all matters relating to the safeguards provided to the Scheduled Tribes under the Constitution or under any other law for the time being in force or under any order of the Government and to monitor and evaluate the working of such safeguards. The Commission is required to present to the President annually and at such other times as the Commission may deem fit, reports upon the working of those safeguards.

Accordingly, the National Commission for Scheduled Tribes has decided to review the implementation of constitutional safeguards and development programmes/schemes being run for the welfare of Scheduled Tribes in the Telangana State Road Transport Corporation on 30.8.2019 at TSRTC Head Quarter Hyderabad as per programme mentioned below: -


