The association of ST employees of LBSNAA may be asked to attend the meeting. The Liaison Officer for STs in LBSNAA may also be asked to attend the meeting with association of ST employees of LBSNAA and review meeting.

4. It is therefore, requested that the requisite information may please be sent to the NCST at the earliest, for examination and for fixing the date, time and venue of the Review Meeting.
