As aware, the National Commission for Scheduled Tribes set up under Article 338A of the Constitution is vested with duties inter-alia, to investigate and monitor all matters relating to the safeguards provided to the Scheduled Tribes under the Constitution or under any other law for the time being in force or under any order of the Government and to monitor and evaluate the working of such safeguards.

Accordingly, the National Commission for Scheduled Tribes has decided to review and assess the implementation of development programmes / schemes being run for the welfare of Scheduled Tribes in the **RAJASTHAN RAJYA PARYATAN VIKAS NIGAM Ltd. (Rajasthan Tour Development Corporation)**. A copy of the Questionnaire for Public Sector Undertaking Review is enclosed for furnishing information by the Ministry. Replies to various issues covered in the Questionnaire form the basis for the Review Meeting in **RAJASTHAN RAJYA PARYATAN VIKAS NIGAM Ltd. (Rajasthan Tour Development Corporation)**.
