Sub: Review of Constitutional Safeguards for Scheduled Tribes of CCL

महोदय,

The National Commission for Scheduled Tribes (NCST) has been set up under Article 338A of the Constitution of India vested with responsibility *inter-alia* to investigate and monitor all matters relating to the safeguards provided to the Scheduled Tribes under the Constitution or under any other law for the time being in force or under any order of the Government and to monitor and evaluate the working of such safeguards. The NCST is required to present to the Hon'ble President of India, annually and at such other times as the Commission may deem fit, reports upon the working of those safeguards.

- 2. Accordingly, the NCST has decided to review the implementation of constitutional safeguards including reservation policy in respect of your organization on 13.06.2024 and 14.06.2024 at Ranchi. The NCST has evolved a questionnaire for review, a copy of the same is enclosed for furnishing replies / information by your Organization. A copy of the Questionnaire is available in the NCST's website. http://ncst.nic.in/content/questionnaire-review-psusbankshospitalseducation-download is also. The replies to various issues covered under the questionnaire will form the basis for review meeting.
- 3. It is requested that replies / information in respect of questionnaire may be prepared and furnished (six copies) to this Commission within one week from receipt of the letter. A soft copy of the replies to the questionnaire may also be sent to js@ncst.nic.in for record. A brief presentation along with measures / programmes taken up by CCL for welfare of Scheduled Tribes in the country may also be made during the review meeting before the Commission.
- 4. Dr. Asha Lakra, Hon'ble Member, NCST will Chair the review meeting with you and Sr. officers of CCL on 13.06.2024 at 11:00 AM in CCL at Ranchi. It is also informed that the Hon'ble Member will have a discussion on the grievances and problems of ST employees with office bearers of SC/ST employees welfare association of CCL alongwith ST employees of CCL before the review meeting on 13.06.2024 at 10:00 AM in CCL at Ranchi.
- 5 It is therefore, requested that arrangements for photographs may please be made during the review meeting. Appropriate backdrop for review meeting may also be arranged / displayed at the venue during the meeting and other places.

It is also requested that office bearers of SC/ST employees welfare association of CCL, ST employees of CCL and Liaison officer for STs of CCL may be asked to attend the meeting on 13.06.2024 at 10:00 AM in CCL at Ranchi before review meeting.
