Sub: Review of Constitutional Safeguards for Scheduled Tribes of Tirumala Tirupati Devasthanams (TTD), Tirupati.

महोदय.

The National Commission for Scheduled Tribes (NCST) has been set up under Article 338A of the Constitution of India vested with responsibility *inter-alia* to investigate and monitor all matters relating to the safeguards provided to the Scheduled Tribes under the Constitution or under any other law for the time being in force or under any order of the Government and to monitor and evaluate the working of such safeguards. The NCST is required to present to the Hon'ble President of India, annually and at such other times as the Commission may deem fit, reports upon the working of those safeguards.

- 2. Shri Jatothu Hussain, Hon'ble Member, NCST has decided to have a review of TTD on 16.08.2024 regarding the structure, functioning, sanctioned staff strength (including posts reserved for STs) and schemes/programmes implemented by TTD for the welfare of Scheduled Tribes in TTD. The review may include, inter alia, the following:
 - a. Structure and function of TTD.
 - b. Total sanctioned staff strength (Post-wise) and posts reserved for Scheduled Tribes and present position.
 - c. Details of schemes/programs implemented by TTD.
 - d. Allocation and utilization of funds during last three financial years and current year, i.e. 2024-25.
- 3. It is requested that replies / information on the above points may be prepared and furnished (six copies) to this Commission by 12.08.2024 positively. A soft copy of the replies /information may also be sent to Email:- m.ingudam@sansad.nic.in for record. A brief presentation along with measures / programmes taken up by TTD for welfare of Scheduled Tribes in TTD may also be made during the review meeting before the Commission.
- 4. The review meeting with you and other Sr. officers of TTD will be held on 16.08.2024 at 11:30 AM in TTD, which is to be chaired by Shri Jatothu Hussain, Hon'ble Member, NCST. It is also informed that the Hon'ble Member will have a discussion on the grievances and problems of ST employees with office bearers of SC/ST employees welfare association of TTD alongwith ST employees of TTD before the review meeting on 16.08.2024 at 11:00 AM in TTD at Tirupati.
- 5. It is therefore, requested that arrangements for photographs may please be made during the review meeting. Appropriate backdrop for review meeting may also be arranged / displayed at the venue during the meeting and other places.
