महोदय,

The National Commission for Scheduled Tribes (NCST) has been set up under Article 338A of the Constitution of India vested with responsibility, inter-alia to investigate and monitor all matters relating to the safeguards provided to the Scheduled Tribes under the Constitution or under any other law for the time being in force or under any order of the Government and to monitor and evaluate the working of such safeguards. The NCST is required to present to the Hon'ble President of India, annually and at such other times as the Commission may deem fit, reports upon the working of those safeguards.

- 2. Accordingly, the NCST has decided to review the implementation of constitutional safeguards including reservation policy in respect of your University. The NCST has evolved a questionnaire for review, a copy of the same is enclosed for furnishing replies / information by your University. A copy of the Questionnaire is available in the NCST's website. http://ncst.nic.in/content/questionnaire-review-psusbankshospitalseducation-download.
- 3. It is requested that replies / information in respect of questionnaire may be prepared and furnished (six copies) to this Commission within two week from receipt of the letter. The replies to various issues covered under the questionnaire will form the basis for review meeting. A soft copy of the replies to the questionnaire may also be sent to Secretary, NCST on Email: secy@ncst.nic.in for record. A brief presentation along with measures / programmes taken up by NDVSU for welfare of Scheduled Tribes in the country may also be made during the review meeting before the Commission.
- 4. In this context, it is mentioned that Review Meeting with you and other Senior Officers of NDVSU on 30.08.2024 at Jabalpur, Madhya Pradesh will be chaired by Shri Antar Singh Arya, Hon'ble Chairperson, NCST. It is also informed that Hon'ble Chairperson will have a discussion on the grievances and problems of NDVSU Students and Employees with office bearers of SC/ST Employees Welfare Association of NDVSU before the Review Meeting 30.08.2024in NDVSU at Jabalpur. Madhya Pradesh.
- 5. It is therefore requested that arrangements for photographs may please be made during the Review Meeting. Appropriate back drop for the Review Meeting may also be arranged/displayed at the venue during the meeting and other places.

- 6. It is also requested that the office bearers of SC/ST Employees Welfare Association of NDVSU, ST Students of the NDVSU and Liaison Officer for STs of NDVSU may be asked to attend the meeting on 30.08.2024 before the Review Meeting.
