Tour visit of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes (NCST), New Delhi to ZP High School, Gudur, Mahabubabad District on 14.11.24

Tour report of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes (NCST), New Delhi to ZP High School , Gudur, Mahabubabad District Telangana on 14.11.24 to Review the implementation of Constitutional Safeguards

The National Commission for Scheduled Tribes (NCST) is a constitutional body set up under Article 338A of the Constitution of India to investigate and monitor all matter relating to protection, welfare and socio-economic development of Scheduled Tribes in the country. As per constitutional provisions, the Union and every State Govt. shall consult the Commission on all major policy of decisions affecting Scheduled Tribes. The Commission is required to present to the Hon'ble President of India reports upon working of those safeguards and all such reports are to be laid before each House of Parliament along with Memorandum explaining the Action Taken or proposed to be taken on the recommendations relating to the Union and the reasons for non- acceptance, if any, of any of such recommendations.

- 2. In pursuance of the above constitutional mandate, Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes accompanied by Dr P Kalyan Reddy, Director, NCST and Shri Ashok Lakkarasu, PS to Hon'ble Member (JH) visited ZP High School, Gudur, Mahabubabad District Telangana State to understand the nature of grievances of STs in School and redressal mechanism and to give certain recommendations for effective implementation of constitutional safeguards for the students belonging to Scheduled Tribes.
- 3. The school being located in a ST dominated mandal and it is in this school the Hon'ble member has studied his class X during 1997-1998. The Commission has received certain representations from the employees, staff, teachers, and Student community with regard to the following issues.

- 1. It is observed that the enrollment strength is decreased drastically to 200 in comparison to the enrolled strength of over 1000+ children before the year 2000. This is due to the conversion of the primary schools to High schools in the neighboring villages and opening up of new Residential schools.
- 2. The building is an oldest structure built nearly 5 decades ago and is being in dilapidated state especially the 6^{th} and 7^{th} class rooms.
- 3. Due to the low lying ground the Rain water is being inundating the ground causing water logging as there is no drainage system. As the neighboring Girls High school is on the elevation the water is stranded.
- 4. The Bathrooms constructed under Manavooru-Manabadi by the previous Government are incomplete and are not handed over by the contractor. Further the school is not covered under Adarsha patashalalu of current Government.
- 5. The Dining Hall is constructed as per the design but it became home to the Monkeys and being unused as there are no proper grills.
- 6. There are no facilities of computer lab, science lab, library, RO Plant etc.,
- 7. There is no whitewashing of the school and floor on verandah needs renovation. Lapses of Manavooru- Manabadi are seen.
- 8. It is reported that budget is sanctioned for the sports but not released. Children are enthusiastic to play Volleyball, shuttle badminton, Kho Kho, caroms and chess.
- 9. There is a severe staff shortage. The staff got retired and no new staff is placed. Night watchman, office subordinate and scavengers are required. They can be engaged through ZP CEO but are not engaged so far.
- 10. Maintenance Grant/School Grant is very meager and may be increased from current 25000 Rs.
- 11. Certain support from Rotary Club has been made. 3 cycles were provided which is an encouragement for the children.
- 5. The Commission has made the following recommendations and has suggested providing the following information.
 - 1. The Panchayat Raj Department, MRO and DEO may take necessary action to renovate the existing buildings and send the

- necessary proposals to the District Collector and Education Department to take up necessary infrastructural requirements.
- 2. The teachers may also try to get the works done through the alumni who have studied in the school and through corporate social responsibility.
- 3. The Principal/Head master of the school may prepare consolidated proposals and submit to the authorities concerned.
- 4. Certain immediate requirements which can be attended may be made available. For example the sports kit, drinking water through mission bhageeratha.
- 5. The Panchayat Raj Department may ensure that the pending works of Toilets and Dining hall are completed and handed over immediately.
- 6. The teachers may be proactive and camp in the surrounding villagers and drive the drop out children into the schools
- 7. The teachers may be friendly with the children and may inculcate the curiosity and enthusiasm in the children with their practical way of teaching rather than rote learning.
- 8. ZP CEO may take necessary action in placing the subordinate staff in the school.
- 9. The MRO/DEO may submit the proposal to the Government for the enhancement/revision of Maintenance grant. The released Maintenance grant may be used prudently with transparency.
- 10. The local gram panchayat may be vigilant on the requirements and performance of the school.
