- (a) Allocation of Funds under TSP and major areas of its utilization;
- (b) Implementation of policies by Oil Marketing Companies (OMCs) regarding reservation in appointments and promotions and status on backlog;
- (c) Welfare policies and programmes of Ministry and its OMCs for the STs;
- (d) Policies of OMCs in providing reservations and concessions for the dealerships/Retail outlets/ Fuel Transport contracts to STs;
- (e) Whether allotment has been made to STs for outlets/dealerships and benefits provided under their reservation policy for STs and if not, reasons thereof;
- (f) Whether benefits/concessions extended under policies of OEM's for the outlets/ retail dealership/ fuel transport contracts allotted to STs are adequate; and
- (g) Recommendations by the Standing Committee for SCs/STs, if any, to mitigate the difficulties encountered by the STs and action taken by the OMCs thereon.
