Subject: Inclusion of "Puran" community in the list of STs in the State of Jharkhand.

The Welfare Department, Government of Jharkhand vide letter No. 627 dated 11.12.2001 had recommended for inclusion of 'Puran' community in the Scheduled Tribes in Jharkhand State **(copy enclosed)**. As per the approved modalities, the recommendation alongwith justification furnished by the Government of Jharkhand was referred to the Registrar General of India for comments/views. The RGI vide D.O. No. 8/1/2004-SS (Jharkhand) dated 02nd December, 2005 had furnished its comments **(copy enclosed)**. The Office of the RGI had not supported the proposal for inclusion of 'Puran' community in the list of STs in Jharkhand State.

The comments of RGI were sent to the Government of Jharkhand vide this Ministry's letter dated 27.9.2007 **(copy enclosed)** with the request that further justification in support of 'Puran' community in ST list on the observation made by the ORGI may be furnished for further action.

The Administrative Reforms Department, Government of Jharkhand vide letter No. 7/5-02-2006/2001 dated 1652 dated 12th October, 2012 has furnished clarification/justification in response to the comments of Office of the Registrar General of India dated 02nd December, 2005 and recommended for inclusion of 'Puran' Community in the list of Scheduled Tribes in Jharkhand **(copy enclosed)**.

As per the approved modalities, the recommendation alongwith justification furnished by the Government of Jharkhand was referred to the Registrar General of India for comments/views. The Registrar General of India, vide their D.O. letter No. 8/1/2013-SS (Jharkhand) dated 3rd

January, 2014 has furnished its comments (copy enclosed). The Office of the RGI has supported the proposal for inclusion of 'Puran' Community in the list of Scheduled Tribes in Jharkhand State.

It is requested that comments/views of National Commission for Scheduled Tribes for inclusion of the aforesaid community in the list of Scheduled Tribes in Jharkhand State may be furnished to this Ministry, urgently.
