

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Smt. Vankudoth Chilakamma of Badi Thanda of Seethampeta Gram Panchayat, Garla Mandal, Mahabubabad District regarding her name missing in land records.

Date of the Sitting: 08/04/2025, 10:40AM

Smt. Vankudoth Chilakamma of Badi Thanda, Seethampeta Gram Panchayat, Garla Mandal, Mahabubabad District has represented vide letter dated 16.11.2024 that out of 0.32 guntas of land in her name only 0.08 guntas is reflected in the online records and the MRO is claiming that she does not possess any land other than that.


2. NCST vide notice dated 19.01.2025 sought facts and comments from Collector and District Magistrate, Mahabubabad within 30 days from receipt of the Notice. The reply was not received, hence, NCST decided to discuss the issue with the authority and the petitioner on 08.04.2025. Accordingly, a Sitting Notice was sent on 25.03.2025 to all concerned.

3. In the sitting, the Collector & District Magistrate, Mahabubabad was present and the petitioner joined via phone call.

4. The District Collector has informed that Revenue Divisional officer, Mahabubabad & Tahsildar, Bayyaram have conducted enquiry and reported that the total RSR extent in Sy.No.50 is Ac.7.30 gts. But as per Dharani Portar, total (5) pattadars names were recorded for Ac.7.29 gts., out of which Ac.0.08 gts was recorded in the name of petitioner Smt vankudoth chilakamma w/o Veerya. Further reported that Ac.0.01 gts of RSR extent only available to correct the extent of the petitioner and they are unable to take any action for extent correction due to nonavailability of balance extent in Sy.No.50 in Dharani portal.

5. After discussion with the Collector & District Magistrate, Mahabubabad and the petitioner (joined via phone call), the following recommendations were made and the action taken report may be furnished within 30 days from the receipt of the minutes.

- The documents of all the remaining pattadars in the said survey number to be verified and the extents owned by them may be authenticated.
- The land in the neighboring survey numbers also to be surveyed and verify if the deficit of the claimed land is added in them.
- Efforts may be made to arrive at the clarity on missing 24 Gts and may be added to the petitioners claimed land if found genuine.
