

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Smt Vankudoth Salki of Buddharam Thanda of Garla Mandal of Mahabubabad District regarding alleged encroachment of his land.

Date of the Sitting: 08/04/2025, 02:20PM

Smt Vankudoth Salki of Buddharam Thanda of Garla Mandal of Mahabubabad District vide petition dated 16.10.2024 has represented that her own land was erroneously registered on the name of Vankudoth Bangaree and requested for necessary action.

2. NCST vide notice dated 01.01.2025 sought facts and comments from Collector and District Magistrate, Mahabubabad within 30 days. The reply was not received, hence, NCST decided to discuss the issue with the authority and the petitioner on 08.04.2025. Accordingly, a Sitting Notice was sent on 25.03.2025.

3. In the sitting, the Collector & District Magistrate, District - Mahabubabad was present and the petitioner joined via Phone Call. The Collector & District Magistrate, District - Mahabubabad has informed that the opposite party also belongs to ST community.

4. The District Collector has informed that the Revenue Divisional Officer, Mahabubabad has submitted that the petitioner claimed land is related to Sy No. 106/E to an extent of Ac I 26 gts which was recorded in the name of Vankudoth Kasna in the year 1992-93 and during the LRUP the same extent was recorded in the name of (3) other persons and the total extent was acquired in SRLIP. Further Smt Bangari's land to an extent of 0.20 gts was delivered from 106/EE which was recorded in the name of Vankudoth Sarvan S/o Surya in the year 1992-93 and during the LRUP she has got Patta for an extent of 0.20 gts and out of this extent Acs 0.18 gts land was acquired for SRLIP. The two sub divisions both are different, as per the document submitted by the petitioner, she has purchased the land from Vankudoth Kasna who is Pattadar of Sub Division No 106/E to an extent of Ac I .26gts and it is not related to Smt Bangari's land who got patta from the Sub division No 106/EE to an extent of Ac 3.01 gts. Further, the petitioner never recorded as Pattadar and enjoyer in Sy.No .106/E and at the time of Land Acquisition the petitioner's request was also not considered. The petitioner without any valid documents claimed the land and her grievance cannot be considered.

5. After discussion with the Collector & District Magistrate, District - Mahabubabad and the petitioner. It was observed that the petitioner and opposite party belongs to ST community.

6. Hence, it was decided that no further action is required on part of NCST.
