Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Dharavath Kishan and other ST farmers of Sithanagaram Village, Gudur Mandal, Mahabubabad District regarding their names missing from Dharani portal.

Date of the Sitting: 08/04/2025, 11:00AM

Shri Dharavath Kishan and other ST farmers of Sithanagaram Village, Gudur Mandal, Mahabubabad District, vide letter dated 26.11.2024 have informed that they have been in possession of 277 acres of land in Survey No. 1/5 since 1955-56, cultivating it as their livelihood for over 70 years. They have stated that they held passbooks under the erstwhile United Andhra Pradesh State. The land was recorded in their names. However, after the formation of Telangana State, their names were removed from the Dharani revenue portal in 2013-14 and instead the name of Kaja Abdul Wahid was recorded in the Patta Kalam by revenue officers. Despite continuing to cultivate the land, their applications for mutation submitted to the Collector, Mahabubabad and the Tahsildar, Gudur have not resulted in any action.

2. NCST vide notice dated 13.02.2025 sought facts and comments from Collector and District Magistrate, Mahabubabad within 30 days. The reply was not received, hence, NCST decided to discuss the issue with the authority and the petitioner on 08.04.2025. Accordingly, a Sitting Notice was sent on 25.03.2025.


3. In the sitting, the Collector & District Magistrate, District - Mahabubabad and petitioner were present.

4. The petitioner has stated that in 1955-56 the name of Khaja Abdul Wahid is both in Anubavadaru and Pattedaru and upon their cultivation for decades by the STs the pattas were given only for 50 families for 50 acres in 2019 and for the balance 150 farmers it is not given. Further the petitioner has alleged that on the false assurances of the RI and VRA, the land tax is paid and old pattas were taken back. There were also several mismatches like in the case of Moodu Soorya who was cultivating 7 acres of land but was provided only 13 Guntas of land.

5. The authority has informed that as the seetanagaram being an Agency village the Government should be addressed to give option in Dharani to edit. Further the successors of Khaja Abdul wahid have stated that they have not sold few lands and the pattas were given on the name of STs only to the extent of purchased lands and hence the remaining STs were not provided the pattas.

6. After discussion with the Collector & District Magistrate, District - Mahabubabad and the petitioner, the following recommendations were made and the action taken report may be furnished within 60 days from the receipt of the minutes.

- Immediately after conclusion of Narayanapuram filed survey, the staff may be deputed to Seetanagaram for survey and based on variations of the field report from the book record the same may be informed to CCLA for further necessary action.
