Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of V. Hanumanna and N. Ramu Naik, Senior Technical Work Inspectors, Kurnool District regardingdelegation of powers and assignment of duties of MICs/AEs.

Shri V. Hanumanna and Shri N. Ramu Naik, Senior Technical Work Inspectors working in Kurnool District on an outsourcing basis since 2006, have submitted a representation dated 27.09.2024 seeking delegation of powers and assignment of duties of MICs/AEs in the vacant Mandals of Kurnool Rural and Kallur. They state that there are two vacant posts of OS MICs/AEs in the district and being the senior-most technical staff with relevant experience and ITI (Draughtsman Civil) qualifications, they are eligible to be considered for these positions. They cite the instructions of the Special Chief Secretary to the Government of Andhra Pradesh, the Managing Director, APSHCL and the District Collector of Alluri Seetharamaraju District, where similar appointments have been made, as precedent. They requested the District Collector/Executive Director, APSHCL, Kurnool to grant permission for filling these vacancies at the earliest.

- 2. NCST vide notice dated 09.12.2024 sought facts and comments from the Managing Director, A.P. State Housing Corporation Limited, Vijayawada within 30 days. The Managing Director, A.P. State Housing Corporation Limited, Vijayawada vide his letter dated 30.12.2024 has informed the Commission that in response to the petition from Sri Vamanagiri Hanumanna regarding the utilization of Outsourcing Work Inspectors (OSWIs) as Assistant Engineers (AEs) or Mandal Incharges (MICs), necessary action has been taken. It was stated that following a government order dated 16.04.2022, permission was given to utilize the services of qualified OSWIs with B.Tech/M.Tech/Diploma (Civil) qualifications in vacant AE positions on an outsourcing basis. While two individuals, including the petitioner, have been working since 2006 with ITI qualifications, the use of such personnel was permitted temporarily by some District Collectors only to avoid disruption of work and without any right to claim AE posts. Further, instructions were reiterated during review meetings to use only technically qualified OSWIs for these posts and a detailed report has been requested from the ASR District regarding any deviations. This was sent to the petitioner on 19.01.2025 for information.
- 3. The Commission decided to discuss the issue with the authority and the petitioner on 09.04.2025. Accordingly, a Sitting Notice was sent on 27.03.2025. The MD, APSHCL vide letter dated 7.4.2025 has sought exemption and deputed General Manager to attend the sitting. A factual report on the representation has also been enclosed with the letter.
- 4. In the sitting, the General Manager of APSHCL and petitioner were present. The petitioner reiterated his earlier submission and requested for justice. The General Manager, APSHCL has informed that the petitioner are not having requisite qualification (i.e. Diploma/ B.Tech/M.Tech) to claim the Mandal incharge.
- 5. After discussion with the General Manager of APSHCL and petitioner, it was observed that no action is warranted on part of NCST. However, the details of qualification of each employees (with name of their community / caste) for the said post may be furnished to NCST within 30 days from receipt of the minutes.
