Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of A. Narasimha and others of Bhupatipeta Karampodi Thanda villagers, District - Mahabubabad regarding encroachment of their lands by non STs.

Shri A. Narasimha and others of Bhupatipeta Karampodi Thanda villagers, District- Mahabubabad have represented vide letter dated 16.11.2024 that their lands in survey no 13/13 are being encroached by non STs.

- 2. NCST vide notice dated 12.02.2025 sought facts and comments from Collector and District Magistrate, Mahabubabad within 30 days. The reply was not present, hence, NCST decided to discuss the issue with the authority and the petitioner on 08.04.2025. Accordingly, a Sitting Notice was sent on 25.03.2025.
- 3. In the sitting, the Collector & District Magistrate, District- Mahabubabad was present but the petitioner was not present.
- 4. After discussion with the Collector & District Magistrate, District-Mahabubabad, the following recommendations were made and the action taken report may be furnished within 30 days from the receipt of the minutes.
- A detailed survey may be made at Sy.No 13/13 to ascertain whether these lands are Government Poramboke lands, assigned lands or private purchased lands.

 The team of Revenue authorities may be engaged and Documents may be verified in a drive mode towards resolving the long pending issue expeditiously.
