Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Smt. Gummadi Veeakumari of Mahabubabad District, Telangana Stateregardingpayment of compensation in the case of murder of ST youth.

Date of the Sitting: 08/04/2025, 03:50PM Participants in the Sitting: As per Annexure

Smt. Gummadi Veeakumari of Mahabubabad District, Telangana State, vide her petition dated 15.11.2024 has stated that an ST youth was murdered in Mahabubabad District and she has sought payment of compensation as per the SC/ST (POA) Act, 1989.

- 2. NCST vide notice dated 23.01.2025 sought facts and comments from Collector and District Magistrate, Mahabubabad and Superintendent of Police, Mahabubabad, Telangana within 30 days from receipt of the Notice. The reply was not received, hence, NCST decided to discuss the issue with the authorities and the petitioner on 08.04.2025. Accordingly, a Sitting Notice was sent on 26.03.2025.
- 3. In the sitting, the Collector and District Magistrate, Mahabubabad and petitioner were present. There was no communication from SP, Mahabubabad.
- 4. The District Collector has informed that The FIR and post mortem report submitted by the superintendent of Police, Mahabubabad has been examined and the viciim is eligible for sanction of ex-gratia for 1,t srage amount of 50% of total Rs.g,25,000/- i.e., Rs.4,1t500/- as per provisions.On receipt of the budget recently the Administrative compensation to Officer, Mahabubabad has paid an amount of Rs. 4,12,500/- to the next kin of deceased on 25.3.25.
- 5. The petitioner's family has stated that though they have demanded to find the other culprits, the dog squad was not employed and the male culprit had a broken hand, it is believed that some other also aided and abetted in the murder of the victim.
- 6. After discussion with the Collector and District Magistrate and petitioner, the following recommendations were made and action taken report may be submitting to NCST within 30 days from receipt of the minutes.
- The compensation may be given to the family members of deceased person as per POA Rules.
- The District collector may examine and provide an outsourcing job to the victim's brother.
- The victim's family may be considered for providing a house under Indiramma Illu Housing scheme.
- Police may re-enquire the case properly to see that no culprit escapes.
