

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Banothu Parsha, Jujur Thanda village, Kuravi Mandal of Mahabubabad District regarding registration of petitioner's land in another person's name.

Date of the Sitting: 08/04/2025, 04:10PM
Participants in the Sitting: As per Annexure

Shri Banothu Parsha, Jujur Thanda Village, Kuravi Mandal of Mahabubabad District vide his petition dated 21.11.2024, has alleged that the Tahsildar, Kuravi Mandal has illegally registered his 4-acre agricultural land in another person's name. He has further stated that he has been threatened to withdraw the case filed in the Hon'ble High Court and that the compensation for land acquired by NHA has been stopped.

2. NCST vide notice dated 22.01.2025 sought facts and comments from Collector and District Magistrate, Mahabubabad and Superintendent of Police, Mahabubabad within 30 days. The reply was not received, hence, NCST decided to discuss the issue with the authority and the petitioner on 08.04.2025. Accordingly, a Sitting Notice was sent on 26.03.2025.

3. In the sitting, the Collector and District Magistrate, Mahabubabad and petitioner were present. There was no communication from SP, Mahabubabad.

4. The District Collector has informed that Revenue Divisional officer, Mahabubabad and Tahsildar Kuravi have conducted enquiry and submitted a report stating that on verification of the documents and records, it is noticed that the petitioners requested for payment of compensation of the land acquired for National Highway in Sy.No. 375 covering to an extent of Ac 0.37gts. and 395 to an extent of Ac 0.18 Gts. respectively. succession was done earlier in favor of Smt. B. Krishna Kumari w/o vijendar to the land in Sy. No. 375/A/1/1/2 to an extent of Ac. 1.30gts and Sy No.395/3/2 to an extent of Ac. 2.10gts. In this connection one Sri Banoth Parsha S/o. Rupla and smt. Banoth Buhi wo Parsha have filed wP. No. 2160112023 and WP. No. 417512025 before the Hon'ble High court, Hyderabad against the above Succession.

5. After discussion with the Collector and District Magistrate and petitioner it is concluded that As the matter is sub-judice before the Hon'ble High court, Telangana and as a family/civil dispute has arisen regarding ownership and compensation, NCST could not intervene.
