Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Badavath Kishore, Mahabubabad regarding non-mutation of land by revenue authorities.

Date of the Sitting: 08/04/2025, 02:30 PM Participants in the Sitting: As per Annexure

Shri Badavath Kishore, Mahabubabad, vide his petition dated 13.10.2024, has stated that the administration has not taken any action despite several requests made by his father for the mutation of 3.10 acres of land in Errakunta Thanda of Gudur Mandal, Mahabubabad District.

- 2. NCST vide notice dated 01.01.2025 sought facts and comments from Collector and District Magistrate, Mahabubabad within 30 days. The reply was not received, hence, NCST decided to discuss the issue with the authority and the petitioner on 08.04.2025. Accordingly, a Sitting Notice was sent on 26.03.2025.
- 3. In the sitting, the Collector and District Magistrate, Mahabubabad was present and the petitioner joined via Phone Call.
- 4. The District Collector has informed that the Revenue Divisional Offrcer, Mahabaubabad and Tahsildar, Gudur have submitted report stating that the applicants grandfather Sri Badavath Gobriya has purchased the said land from Sri Mohamood Hasan, who is the pattdar of the land in Sy.No. 26 of Boddugonda village of Gudur mandal and on verification of the office record, Sri Mohammed Mahmood Hasan is recorded as pattedar from 1954-55 and after demise of his grandfather, the mother of the applicant Smt Badavath Lakshmi Wo. Bodiya was recorded as cultivator from the year 2002-03.
- 5. Further, from the year 2010-11 sri Badavath venkanna s/o. Bodiya was recorded as cultivator for the above said land till 2016. But since purchase of the land from the pattedar his grandfather and other family members were recorded only in cultivator column. Later sri Badavtha Kishore has purchased the land to an extent ofAc 0-20 Gts in sy.No. 26 situated at Boddugonda village of Gudur mandal from his brother Sri Badavath Venkanna S/o Bodiya, by sada deed on 22.3.2017, who was also recorded as cultivator. But the applicant was never in cultivation of the said land since purchase. The Revenue Divisionar officer, Mahabubabad and rahsildar, Gudur has concluded that the request ofthe appricant cannot be considered for issue of e-ppB as they have no title for the land in sy.No. 26/A to an extent of Ac 0-20 Gts situated at Boddugonda vilrage of Gudur Mandal' The applicant got the rand through sada sare deed and issue ofe-ppB to the petitioner is not feasibre. Since the Sale deed never regurarized in past and present there is no provision for regurarization of Sadabainama.
- 6. After discussion with the Collector and District Magistrate, Mahabubabad and petitioner (joined via Phone Call), the following recommendations were made and action taken report may be furnished within 30 days from receipt of the minutes.
- Resurvey may be made for the settlement as per the original occupants on the land in the present times.

The District Collector may address to CCLA for resolving the issue.
