


Shri Ajmeera Veeranna and Smt. Azmeera Roja of Chakruthanda, Gudur Mandal, District - Mahabubabad, vide their petition have represented that the FRA title deed under IFR has not been issued despite the survey being conducted and approved for 4.13 acres.

2. NCST vide notice dated 19.1.2025 sought facts and comments from Collector and District Magistrate, Mahabubabad within 30 days. The reply was not received, hence, NCST decided to discuss the issue with the authority and the petitioner on 08.04.2025. Accordingly, a Sitting Notice was sent on 25.03.2025.

3. In the sitting, the Collector & District Magistrate, District - Mahabubabad was present and the petitioner joined via phone call.

4. After discussion with the Collector & District Magistrate, District- Mahabubabad and the petitioner (joined via phone call), the following recommendations were made and the action taken report may be furnished within 30 days from the receipt of the minutes.

- The Commissioner, Tribal Welfare, Telangana may take necessary action in providing the IFR title deed approved by the DLC and sent in the form of PDF passbook to get printed through security printers at Headquarter.
- The District Collector may coordinate with the Director, TCRTI for obtaining the same and handing it over to the petitioner.
