Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Sri BhukyaSrinu of VeeraramThanda, Shanigapuram Mahabubabad District regarding illegal occupation of his land.

Date of the Sitting: 08/04/2025, 12:40PM Participants in the Sitting: As per Annexure

Sri Bhukya Srinu, VeeraramThanda, Shanigapuram Village, Mandal & District-Mahabubabad vide his representation dated 12.11.2024 has alleged that their ancestral land of 49.35 Acres in Revenue Survey Number 275 is illegally occupied by Dr Jannapu Reddy Pramod Reddy and his Benamis and doing Real estate business though legally only 4.36 acres is sold to them.

- 2. NCST vide notice dated 27.1.2025 has referred the matter to the District Collector, Mahabubabad for facts and comments within 30 days from receipt of the notice. The NCST vide notice dated 20.2.2025 has also referred the matter to the SP, District—Mahabubabad for facts and comments within 15 days.
- 3. The reply was not received from the authorities, hence, NCST decided to discuss the issue with the Collector & DM, Mahabubabad and petitioner on 08.04.2025. Accordingly, a Sitting Notice was sent on 25.03.2025.
- In the sitting, the Collector & District Magistrate, District Mahabubabad and the petitioner were present. the Collector & District Magistrate, District - Mahabubabad informed that the petitioner has filed the case before the Hon'ble High Court of Telangana with regard to encroachment of his forefather lands in Sy. No. 275, 278 and 279 of Shanigapuram village of Mahabubabad which was dismissed by the Court. Further, the Hon'ble Civil Courts dismissed the cases filed against the Respondents by the pelitioner and their family members and, the civil suit vide OS No. 88/2024,23912020 cases filed by the petitioner Sri.Bhukya Srinu are also pending before the Hon'ble Civil Courts on the subject lands. Further, it is submitted that, there are many transactions took place in the said lands. As per the enjoyment survey conducted by directions of the Hon'ble High Court of Telangana, Hyderabad many others are in physical possession over the lands in dispute and also noticed that the lands were already converted into Non-Agricultural Purpose. Further, it is submitted that, the petitioner has not submitted any documentary evidences and during the enjoyment survey the petitioner is not in physical possession over the said lands. In view of the abrrve, it is a patta land dispute and the dispute is purely civil in nature. Hence, the subject matter is under Sub Judice, and action may be taken as per the outcome orders of the Hon'ble Courts.
- 5. The petitioner has informed that the matter of civil dispute is pending in High Court and an injunction order with regard to the survey numbers of 270-273-275-278-279 is issued. The opponent Sri Pramod Reddy was given the layout permission without NALA conversion by the authorities. The case is in State SC ST Commission since 2012. Several trespass cases are filed on the petitioner. Meanwhile the permission was accorded to run the Delhi Public school on the disputed land. Admissions are also in progress.

- After discussion with the Collector & District Magistrate, District- Mahabubabad and petitioner, the following recommendations were made and the action taken report may be furnished within 30 days from the receipt of the minutes.
- The records may be traced from 1964 onwards to check how Sri Pramod Reddy got the ownership of ST lands and the AD Survey and settlements may furnish the details as to how much land is purchased and what are the land documents available.

The details of the cases pending in the courts may also be informed to NCST

 Work on the disputed land by the Real estate group may be stopped and Registrations and issuance of pass books may be prohibited on the disputed land to avoid further complications.

The issues relating to Sy.No.287 encroached by Aarthi Gardens and Sy.No.551 encroached by non tribals may also be re verified as they are Government lands and are

affecting the adjacent Tribal habitations.
