## NATIONAL COMMISSION FOR SCHEDULED TRIBES NCST/DEV-3839/TS/134/2024-RO-BHUV

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Banoth Ansurya regarding taking over of his land by revenue authorities

Date of the Sitting: 08/04/2025, 12:40PM Participants in the Sitting: As per Annexure

Shri Banoth Ansurya has represented that their lands in Survey No. 551 of Mahabubabad Revenue Division, Mahabubabad District, have been illegally taken over by the Revenue authorities without any prior notice for the proposed medical college, despite possessing legal documents of lavanipattas.

- 2. NCST vide notice dated 22.01.2025 sought facts and comments from Collector and District Magistrate, Mahabubabad within 30 days. The reply was not received, hence, NCST decided to discuss the issue with the authority and the petitioner on 08.04.2025. Accordingly, a Sitting Notice was sent on 25.03.2025.
- 3. In the sitting, the Collector & District Magistrate, District Mahabubabad and the petitioner were present.
- 4. The District Collector has informed that as per Revenue Divisional Officer, Mahabubabad report, after resumption of the assigned government land to an extent of Ac.21 -00gts in survey number 551 and an extent of Ac.9-00gts in sy.No.551/1 of pure vacant government land, a total to an extent of Ac.30-00 gts of Mahabubabad village has been allotted to the establishment of Medical and Nursing college in the year 2021. Further, some other petitioners have earlier approached the Hon'ble High Court against the allotment of land to Medical and Nursing College and failed to establish their right over the land before the Hon'ble courts. The Hon'ble Courts have disposed some cases where some cases like WP.No.24089 of 2021 filed by Bhukya Balakrishna, WP.No.13678 of 2022 filed by Bhukya Ravi are still pending, and it is submitted that the said issue is sub-judice in these writ petitions before the Hon,ble High Court of Telangana. Hyderabad, without any interim directions against the orders of the allotment of land to Medical and Nursing College. It is also informed that, as of now the construction of Medical College and Nursing College is at completion stage in the allotted lands and also classes are running in some blocks since (02) years.
- 5. The petitioner has informed that 17 farmers have lost 34 acres of land for Medical College in Babu naik Thanda at Survey No.551. The then Tahsildar has threatened and manipulated and a ward member was also murdered which led to total chaos and helplessness of poor tribals
- 6. After discussion with the Collector & District Magistrate, District Mahabubabad and petitioner, the following recommendations were made and the action taken report may be furnished.
- The old documents may be examined and provision of Compensation either monetary or by allocating alternative land may be examined as the petitioners are eking their livelihoods on the said lands.
