Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Smt Banothu Acchamma, Gandhipuram Village, Mandal and District Mahabubabad regarding encroachment of tribal land.

Date of the Sitting: 08/04/2025, 2:00 PM Participants in the Sitting: As per Annexure

Smt Banothu Acchamma, Gandhipuram Village, Mandal and District Mahabubabad vide representation dated 5.11.2024 has represented that her land of around 6.20 Acres at Sy.No.181/C is illegally encroached by Sri Bandi Ramachandra Reddy and Bandi Sriramreddy and requested for survey and doing Justice.

- 2. NCST vide notice dated 21.1.2025 has referred the matter to District Collector & Magistrate, District Mahabubabad for facts and comments within 30 days. The reply was not received. Hence, NCST decided to discuss the issue with the authority and the petitioner on 08.04.2025. Accordingly, a Sitting Notice was sent on 25.03.2025.
- 3. In the sitting, the Collector & District Magistrate, District- Mahabubabad and the representative of the petitioner were present. The Collector & District Magistrate, District-Mahabubabad has informed that the matter is pending before the Hon'ble Court.
- 4. The District Collector has informed that on perusal of the report with connected records submitted by the Revenue Divisional Officer, Mahabubabad, the subject lands in 51.No. 181/C of Anantharam village are belongs to patta lands and the subject matter is involved in civil suits which are still pending viz O.S.No. 0I of 2017 and O.S.No. 142 of 2011 before senior Civil Judge, Mahabubabad and hence the subject matter is subjudice and action may be taken as per the outcome orders of the Hon'ble Courts.
- 5. The petitioner has informed that the land is purchased from Poduru Laxmipathy in 1984 and till 2006 it is on the name of Acchamma . After 2006 Bandi Sriram reddy has created document by fraudulent means which the then Collector Smt Vakati Karuna has cancelled and RDO Bicha Naik has cancelled the passbook. There after Bandi Srinivas Reddy and others continued to approach the High Cout and created litigation. High court of Telangana has passed a common order in WP No.16530 of 2012 and WP.No 20785 of 2011 filed by the respondent Sri. Bandi Ram chandra Reddy and directed the Hon'ble Senior civil Judge, Mahabubabad to dispose the dispute of both the parties preferably, within a period of Six (06) months.
- 6. After discussion with the Collector & District Magistrate, District- Mahabubabad, the following recommendations were made and the action taken report may be furnished within 30 days from the receipt of the minutes.
- The Revenue authorities on behalf of the petitioners may pursue the matter for the quick disposal of the case pending in the Court.
