NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Banoth Balu Naik of Mahabubabad regarding encroachment of his lands by non STs.

Date of the Sitting: 08/04/2025, 11:50AM Participants in the Sitting: As per Annexure

Shri J. Lacchi Ram Naik, Founder and President, Gwarbal Mathro T.S. State Committee, Mahabubabad vide representation dated 10.2.2025 has informed that Shri Banoth Balu Naik of Mahabubabad stating that his land at Survey No 53 is illegally encroached by the Non STs and they have been harassing him.

- 2. NCST vide notice dated 20.02.2025 sought facts and comments from Collector and District Magistrate, Mahabubabad within 30 days from receipt of the Notice. The reply was not received. Hence, NCST decided to discuss the issue with the authority and the petitioner on 08.04.2025. Accordingly, a Sitting Notice was sent on 25.03.2025.
- 3. In the sitting, the Collector & District Magistrate, District Mahabubabad was present but the petitioner joined via Phone Call.
- 4. The District Collector has informed that Revenue Divisional officer, Mahabubabad has submitted that this is purely a civil dispute and sri Banoth Lalu Naik has already approached civil court for redressal grievance of his and there is a case pending on the subject land in sy No. 53 before the Hon,bre High court . Further Hon'ble High court has arso granted interim stay orders and as such the subject matter is sub judice one.
- 5. After discussion with the Collector & District Magistrate, District Mahabubabad, the following recommendations were made.
- · As the matter is subjudice the intervention of NCST is limited.
- It is advised to the Revenue authorities in all such cases the conduct of gramsabha in the village may be one of the useful mechanisms to authenticate the ownership and occupation of land by the claimants.
