Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Sri Madanlal, Rathiram Thanda, Nellikudur Mandal, Mahabubabad District regarding allotment of land being used by STs to other people.

**Date of the Sitting: 08/04/2025, 11:10AM**  
**Participants in the Sitting: As per Annexure**

Sri Madanlal, Rathiram Thanda, Nellikudur Mandal, Mahabubabad District, vide his petition dated 11.12.2024, has represented that a tank situated in Survey Nos. 130 and 139, covering an extent of 20 acres, which is being used by ST farmers for irrigation, has been illegally allotted as patta land in favour of certain villagers by the MRO.


2. NCST vide notice dated 12.02.2025 sought facts and comments from Collector and District Magistrate, Mahabubabad within 30 days. The reply was not received, hence, NCST decided to discuss the issue with the authority and the petitioner on 08.04.2025. Accordingly, a Sitting Notice was sent on 25.03.2025.

3. In the sitting, the Collector & District Magistrate, District - Mahabubabad and petitioner were present.

4. The petitioner has informed that in 1955-58 records, it is chelkapatta and 30 acres of tank in Kanyakunta Thanda of Nainala of Nellikudur mandal where it is catering for the drinking water, irrigation and needs of the cattle. Now it is recorded as patta on the names of the Banoth Jeevan Kumar and Banoth Rajesh. It is further informed that the revenue officials and police officials colluded with the private parties and have made a public property tank into the private property.

5. After discussion with the Collector & District Magistrate, District- Mahabubabad and the petitioner, the following recommendations were made and the action taken report may be furnished within 30 days from the receipt of the minutes.

- Detailed enquiry may be made and the patta pass book may be cancelled if the said land falls within the limit of FTL.
- The record and link documents of pattas may be furnished to NCST to understand how a tank is made into a patta of an individual.
- District Collector may take immediate necessary action in view of the summer and the utility of the tank for the public purposes.
