Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri A. Seetaram Naik, Ex-MP regarding protection of protection of Sri Hathiram Mutt.

Date of the Sitting: 08/04/2025 at 10:30 AM
Participants in the Sitting: As per Annexure

Sri A. Seetaram Naik, Ex-MP vide his letter dated Nil (Sep, 2024) has stated that a temple has been built for the protection of Sri Hathiram Mutt. But, the Endowments Department is frequently issuing notices threatening its demolition. Furthermore, he has requested that a trust board composed solely of ST Banjaras be constituted to safeguard the Mutt's properties.

2. NCST vide notice dated 14.02.2025 sought facts and comments from the Chief Secretary, Government of Andhra Pradesh and the Principal Secretary, Endowment Department, Govt. of Andhra Pradesh within 30 days. The Endowments Department, Govt. of AP vide letter no. REV01-ENDW/142/2025 dated 27.02.2025 sought time of 2 more months to submit a reply on the petition.


3. NCST decided to discuss the issue with the authority and the petitioner on 08.04.2025. Accordingly, a Sitting Notice was sent to Chief Secretary, Government of Andhra Pradesh and Special Chief Secretary, D/o Revenue, Govt. of Andhra Pradesh and petitioner on 26.03.2025.

4. Secretary, Revenue (Endowments) Department and Ex officio Member, TTD Trust Board, Govt. of Andhra Pradesh, Amravati vide letter dated 3.4.2025 has furnished the facts and requested to exempt the Chief Secretary, Government of Andhra Pradesh and Special Chief Secretary, D/o Revenue, Govt. of Andhra Pradesh to appear in person on 8.4.2025 and deputed Commissioner (FAC), Endowments Department, Govt. of Andhra Pradesh, Vijaywada.

5. In the sitting, Commissioner (FAC), Endowments Department, Govt. of Andhra Pradesh, Vijaywada was present. But the petitioner was absent. The Commissioner (FAC), Endowments Department reiterated the facts submitted by Secretary, Revenue (Endowments) Department vide its letter dated 3.4.2025. The authority has informed that before independence Hathiram Mutt used to manage TTD and as per 2006 WA Order existing Mutt adhipathi took a stay order not to appointment any others.


6. After discussion with the Commissioner (FAC), Endowments Department, Govt. of Andhra Pradesh, Vijaywada, the following recommendations were made and action taken report may be furnished within 30 days from receipt of the minutes.

- The fresh survey in respect of demarcation Land of Hathiram Mutt may be undertaken by the Endowments Department, Govt. of Andhra Pradesh, Vijaywada
- The details of land owned by the Hathiram Mutt as per the old original record may be furnished to NCST.
- The details of the court cases pertaining to the Hathiram mutt's land encroachment may be furnished to NCST.
- The details of properties of Hathiram mutt across the country and the management at present may be furnished to NCST.
- The illegal activities of Ganja peddling etc in the premises of Mutt may be curtailed and controlled.
- The issue of allowing Banjara Priests may be examined.
