Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Bhukya Narsi, Guguloth Eerya, Bhukya Chandulal, Bhukya Mangilal, and Daravath Laxmi (ST Lambadis) of Bhukya Dasru Thanda, Seetanagaram Village, Gudur Mandal, Mahabubabad District regarding being barred from cultivating forest land that they had been cultivating since long time.

Date of the Sitting: 08/04/2025, 03:10PM Participants in the Sitting: As per Annexure

The petitioners, Bhukya Narsi, Guguloth Eerya, Bhukya Chandulal, Bhukya Mangilal, and Daravath Laxmi (ST Lambadis) of Bhukya Dasru Thanda, Seetanagaram Village, Gudur Mandal, Mahabubabad District have represented vide rep dated 22.06.2024 that they are poor STs belonging to the ST Lambadi community and have been cultivating forest land for the past 30 years. However, forest officials have stopped allowing them to cultivate the land for the past two years.

- 2. NCST vide notice dated 04.12.2024 sought facts and comments from Collector and District Magistrate, Mahabubabad and DFO, Mahabubabad within 30 days. The reply was not received, hence, NCST decided to discuss the issue with the authorities and the petitioner on 08.04.2025. Accordingly, a Sitting Notice was sent on 26.03.2025.
- 3. In the sitting, the Collector and District Magistrate, Mahabubabad and petitioner (Shri Bhukya Mangilal) were present. The DFO, Mahabubabad was not present and also no information.
- 4. The District Collector has informed that as per the report of DFO as per the cartosat imagery 2005 the petitioners have not cultivated the said land since 30 years in the compt.No.1037 of Ponugodu Reserve Forest of Guduru Range. The Petitioners had never in possession of the said lands, the lands having bushy growth and the same land is under the control of Forest Department since long back. Further, it is submitted that, as per the instructions of Higher officials, they have taken-up the silvicultural operations in the said area and also raised the NTSH Plantation of 12.00 Ha., in the same area during the rainy season of the year 2022-23.
- 5. It is further informed that the petitioners have filed the cases in Hon'ble High court of relangana in WP'Nos., 31166 of 2022 & 12515 of 2023 regarding the same issue and also department officials have filed fair counters on dated 31.07.2023 and the both cases were "Pending" in Hon'ble High Court of Telangana at present.
- 6. After discussion with the Collector and District Magistrate, Mahabubabad and petitioner (Shri Bhukya Mangilal), the following recommendations were made and action taken report may be submit to NCST within 30 days from receipt of the minutes.
- The DLC may examine the issued ROFR IFR title deeds of series No. RoFR022300. and enquire how
 the same were issued without any survey.

As this matter is subjudice before the Hon'ble High Court, Telangana NCSTs intervention is restricted.
