Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at LokNayak Bhawan, New Delhi in the case of Smt. Guguloth Gamsi, Smt. Banoth Laxmi and others regarding misappropriation of land meant for ST families that had been bought by ITDA.

Date of the Sitting: 08/04/2025, 03:00 PM

Smt. Guguloth Gamsi, Smt. Banoth Laxmi and others vide their petition dated NIL, have stated that 9.38 acres of land was purchased under the Land Purchase Scheme by ITDA, Eturunagaram, in 2008 and registered in the names of ten poor families in VS Laxmipuram village. However, they allege that the land has neither been handed over to them nor have they been issued passbooks. Further, they claim that Marneni Paramma and Punyaparthi Narimhulu have illegally sold the land to others, despite the existence of Encumbrance Certificates (ECs) in their names from 2008 to 2015. They have therefore requested that SC/ST Atrocities Act cases be registered against those responsible for this alleged fraudulent transaction.

2. NCST vide notice dated 22.01.2025 sought facts and comments from the Collector and DM, Mahabubabad within 30 days from receipt of the Notice. The reply was not received, hence, NCST decided to discuss the issue with the authority and the petitioner on 08.04.2025. Accordingly, a Sitting Notice was sent on 26.03.2025.

3. In the sitting, the Collector and District Magistrate, Mahabubabad and the representative of petitioners were present.

4. After discussion with the Collector and District Magistrate, Mahabubabad and representative of petitioners, the following recommendations were made and action taken report may be furnished within 30 days from receipt of the minutes.

- The PO, ITDA, Eturunagaram may submit the detailed report in the matter.
