Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Smt. Bhukya Eramma, Laxman Thanda, Village Chinnayellapur, Gudur Mandal, District — Mahabubabad regarding non granting of rights under FRA to ST persons.

Date of the Sitting: 08/04/2025, 03:10PM Participants in the Sitting: As per Annexure

Smt. Bhukya Eramma, Laxman Thanda, Village Chinnayellapur, Gudur Mandal, District—Mahabubabad has submitted a representation dated 13.10.2024 stated that the forest land cultivated by them is not granted rights under FRA Act by Administration and is also taken for Harita haram plantation by the Forest Department.

- 2. NCST vide Notice dated 1.1.2025 has referred the matter to DFO, Mahabubabad for facts and comments. The reply was not received, hence, NCST decided to discuss the issue with the concerned authorities and petitioner on 27.3.2025. Accordingly, a sitting notice issued on 13.3.2025.
- 3. In the sitting, the Collector and District Magistrate, Mahabubabad was present. There was no communication from DFO, Mahabubabad and petitioner was also absent.
- 4. The District Collector has informed that the District Forest offtcer, Mahabubabad has submitted that, the Forest Range Officer, Kothaguda, Forest Section Officer, Kothaguda and Revenue Inspector Kothaguda along with claimants have conducted the field inspection on dt:31'01.2025' proceeded to the Chinnayellapuram Village to verify the Representation received fiom Smt Bhukya Eeramma W/o Eerya R'/o Laxman Thanda regarding issue of RoFR. On the field verification the said land is covered with jungle growth and staggered trenches the claimant is not in Possession the land is under control offthe Forest Department. The land is located at Kothaguda Beat of compartment No 684/1 Kothaguda Section, Kothaguda Range of wild life Gudur Division.
- 5. Further it is informed that The Revenue Divisional Officer, Mahabubabad reported that, Smt. Bhukya Eeramma wo. Bhikya R/o. chinnaYellapur village of Gudur Mandal has submitted on verification of field as shown by the applicant and as per records, the land is situated in forest compartment and not patta land. Further reported that, at present there is forest plantation in the said land. Hence as per the District Forest Officer, Mahabubabad and Revenue Divisional Officer, Mahabubabad report the claimant is not having possession and not cultivating the said land.
- 6. After discussion with the Collector and District Magistrate, the following recommendations were made and action taken report may be submitted to NCST within 30 days from receipt of the minutes.
- The report of the Forest Rights Committee and Gram sabha resolution may be obtained to authenticate
 the genuineness of the claim and to take necessary action as per the provisions of The Scheduled
 Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006
