Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case Ms. B. Shanta, Retd. MTS, AP&T GDC, Survey of India, Hyderabad regarding Non-inclusion in CCS(Pension) Rules.

Date of the Sitting: 09/04/2025, Participants in the Sitting: As per Annexure

- Ms. B. Shanta, Retd. MTS, AP&TG, DC, Survey of India, Hyderabad vide her representation dated 15.12.2024 has stated that she was appointed as Mali on daily wage basis in 1973 till 1990. In July 2003 an advertisement was issued for 10 posts of Khalasis but the department initially refused to consider her for that posts. However, after approaching Hon'ble C.A.T., she was appointed in August 2005 and retired in November 2021 after availing new pension scheme. She further states that since she was appointed against advertisement issued in July, 2003, she is eligible for old pension system under CCS(Pension) Rules in place of National Pension System, which has been given to her.
- 2. NCST vide Notice dated 13.2.2025 has referred the matter to Surveyor General of India, Dehradun (Uttarakhand) for facts and comments within 30 days from receipt of the Notice. The reply was not received, hence, NCST has decided to discuss the issue with the concerned authority and petitioner on 09.4.2025. Accordingly, a sitting notice issued on 26.3.2025. The Addl. Director Surveyor General of India, Dehradun vide letter dated 3.4.2025 has informed that the matter pertains to Director, AP&T GDC, Hyderabad. Hence, he is authorise to attend the sitting with relevant documents.
- 3. In the sitting, the Director, AP&TG, DC, Hyderabad and petitioner were present. The Director has submitted a letter dated 9.4.2025 in the sitting and stated that require documents are established / obtained and the case of the petitioner will be honoured immediately on completion of the formalities. The old pension will be released / fixed in favour of the petitioner.
- 4. After discussion with the Director, AP&TG, DC, Hyderabad and petitioner, it was observed that the department will take appropriate action to resolve the issue. Hence, no further action is warranted on part of NCST and the case may be closed. However, the department is advised to submit the report on the action taken by them in this matter.
