Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Smt. Bantupalli Parvathi, W/o Polipalli regarding illegal registration of her land by third parties.

Date of the Sitting: 08/05/2025, 4:30 PM

Smt. Bantupalli Parvathi, W/o Polipalli, vide rep dated 08.07.2023 has submitted that she has been in continuous possession and cultivation of land measuring Ac. 3.90 cents in Survey No. 65-2, 65-2P of Kondakenguva Village, Ramabhadrapuram Mandal, Vizianagaram District, Andhra Pradesh, which she claims to have inherited from her ancestors. Despite her possession and the issuance of Pattadar passbooks and 1B records by the Tahsildar, Ramabhadrapuram, in her name, certain landlords belonging to the Backward Classes community allegedly got the land registered in their names in 2007 based on the claim that it belonged to the family of one Poyiri Dalayya. Although no possession was taken post-registration, the said parties allegedly manipulated the revenue records in 2020 to reflect the registered ownership. She states that she and her neighboring tribal farmers have been the rightful cultivators for over 60 years and that she belongs to a Scheduled Tribe community with limited knowledge of official procedures. She has requested the Commission to instruct the authorities to cancel the illegal registration, restore the revenue records in her favor, to resolve the issue.

2. In this matter, sitting was held on 26.11.2024 in which the following recommendations were made and minutes sent on 2.1.2025.

- i. The Registration documents available with the Non Tribals may be examined in detail.
- ii. The Mutation procedure may be examined if it is done as per process.
- iii. The Gram sabha resolution and elders statement may be considered to examine the genuinity of the claim of the ST.
- iv. Status quo may be maintained in favour of the ST and Protection may be provided by the District Revenue authorities and Police personnel till the issue is resolved.
- v. The Revenue authorities may resolve the issue in 15 days time and submit the.

3. The Collector & District Magistrate, Vizianagaram vide letter dated 5.3.2025 has requested to grant some more time to submit the ATR, as the matter is pending under enquiry at the Revenue Divisional Officer, Bobbili. Hence, NCST decided to discuss the issue with the authority and the petitioner on 08.05.2025. Accordingly, a sitting notice was sent on 29.04.2025.

4. In the sitting, the Supdt. (Tehsildar Cadre), Collector Office Vizianagaram was present on behalf of Collector & District Magistrate, Vizianagaram. The petitioner was also present. The petitioner reiterated his earlier submission and requested for justice. The Supdt. (Tehsildar Cadre) has provided a letter no. 1835/2024/D4 dated 5.5.2025 of the Collector & District Magistrate, Vizianagaram alongwith report dated 1.5.2025 of the Revenue Divisional Officer, Bobbili and Ramabhadrapuram. In the letter it has been mentioned that the matter has been taken up with the District Registrar and Stamps, Vizianagaram to enquire into the matter. As and when report received from them the necessary action will be initiated against fraudulent registration.

5. After Discussion with the Supdt. (Tehsildar Cadre), Collector Office Vizianagaram and petitioner, the following recommendations were made and action taken thereon may be submit to NCST within 30 days from receipt of the Minutes.

a. Based on the report submitted by the Revenue Divisional Officer, Bobbili upon filed enquiry, the fraudulent registration made at Sub Registrar office, Gajapathinagaram vide Documents number 1048/2007 dt.6.3.2007, 1049/2007 dt.6.3.2007 may be cancelled by the District Collector/District Registrar.


b. Status quo may be maintained till the issue is resolved.
