Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad, in the case of Jatoth Devender, Banjara Nagar, Mahabubabad district, Telangana regarding denial of appointment as Veterinary Assistant by TSPSC.

Date of the sitting: 24.05.2025 at 12:10 (Noon)

Shri Jatoth Devender, resident of Dubbatanda, Thorururu- Mandal, District Mahabubabad vide his petition dated NIL has stated that despite clearing the recruitment examination for the post of Veterinary Assistant under TSPSC Notification No. 30/2017 dated 12.06.2017 and completing web options and certificate verification, an appointment order has not been issued by the authority. Due to this W.P. No. 28180/2018 filed before the Hon'ble Telangana High Court and the Single Judge Bench passed an order on 30.10.2023 which was positive. Despite this, TGPSC did not issue the appointment order and instead filed an appeal W.A. No. 692/2024 dated 21.11.2024 before the Division Bench, which also ruled in his favour. Yet, the TSPSC has failed to comply. Hence, do the justice.

- 2. NCST vide notice dated 07.04.2025 sought facts and comments from the Secretary, Telangana Public Service Commission (TGPSC), Hyderabad within 07 days from receipt of the Notice. The issue was discussed in the sitting scheduled on 8.5.2025 at Delhi with the officers of TGPSC and petitioner (via phone). However, the issue remain unresolved. Hence, the Commission decided to discuss the issue with the authorities and petitioner on 24.05.2025 at Hyderabad. Accordingly, a sitting notice was sent on 19.05.2025.
- 3. In the sitting, Secretary, TGPSC, Director, D/o Animal Husbandry, Govt. of Telangana were present. The petitioner was also present.
- 4. The authority has informed and submitted the copy of the Orders of Single Bench Judge in same recruitment dismissing the case of Sri Banoth Laxman and other ST candidates who got higher marks than ST Agency Area candidates challenging the selection of lower merit ST Agency Area candidates instead of higher merit ST Non-Agency area candidates. Further the Orders of Division Bench are also submitted relating to the same recruitment dismissing the case of Sri Banoth Laxman and other ST candidates who got higher marks than ST Agency Area candidates challenging the selection of lower merit ST Agency Area candidates instead of higher merit ST Non-Agency area candidates. It is further informed that petitioners actual Marks are 102 only and (1) ST Agency Area candidate, 3 PH (OH) candidates and (13) ST Non-Agency Area candidates are above on him who didn't get selected.
- 5. The petitioner informed that he has proofs that he got 107 marks and has the GOs in his favor that meritorious plain area candidates can be filled in the vacancies.
- 6. After hearing to both the parties the following recomendations were made by NCST. The ATR may be submitted in 15 days from the receipt of Minutes.
- a. The marks and General ranking list may once again be verified by TGPSC to verify the correctness of the claim of petitioner

b. The merit list of ST and PH Candidates of Warangal District may be rechecked.

c. The petitioner may submit a copy of all the documentary evidences available with him in favor of his claim to TGPSC for further verification and arrival of clarity on this issue.
