## NATIONAL COMMISSION FOR SCHEDULED TRIBES (NCST/ATY-2338/TS/321/2025-RO-BHUV/RU-III)

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Hyderabad in the case of A. Bhadra and E. Soundarya regarding threats of demolition of their house.

The petitioners, A. Bhadra and E. Soundarya, have stated that they have constructed houses on 75 Sq. Yards of land allotted to them, but one Mr. Bandaru Yadiah has been threatening to demolish the houses using fake documents. Despite multiple representations to the authorities, there has been no response or action taken in the matter.

NCST vide notice dated 24.03.2025 sought facts and comments from Collector & District Magistrate, District Medchal Malkajgiri and the Commissioner Of Police, Rachakonda Police Commissionerate, Medchal-Malkajgiri within 30 days. The reply was not received.

The Commission decided to discuss the issue with the authority and the petitioner on 06.05.2025, which was postponed as the petitioner and authority were absent.

Hence, NCST again decided to discuss the issue with the authorities and the petitioner on 15.5.2025 at Hyderabad. Accordingly, a sitting notice issued on 09.5.2025.

In the sitting, the District Collector, Medchal Malkajgiri and the Petitioners were present.

The authority informed there are documents with signatures which show that the land allocated to the petitioners and others was sold to Yadiah.

The petitioners informed that the forged documents are made with no witness and no thumb impresssion and alleged that the out of 86 pattas given to poor vulnerable migrant ST laborers, 75 plots are encroached by Yadiah and has built a guesthouse and installed CC Cameras. The MRO is also not cooperating to address the issue.

After hearing both the sides, the Commission recommends the following and action taken report to be submitted within 30 days -

The land under occupation by Shri Yadiah may be renounced by the Revenue Department as the assigned land is not supposed to be encroached or purchased by the other party.

The police Department may take immediate necessary action on the threats being faced by the petitioners especially with land relating to the Sevalal temple.

A detailed enquiry may be made on the allegations made by petitioners on MRO
