Shri Dharm Singh Meena, Asstt. Manager (Tech.), Delhi Transco Limited (a Government of NCT of Delhi Undertaking), Flat No. 4R701, Gurjinder Vihar, AWHO Township, Greater Noida, Gautam Budh Nagar, Uttar Pradesh, vide his letter dated 28.01.2025, has made complaint to the Commission REGARDING (i) Non-disposal of Appeal for replacement of Inquiry Officer (IO), Shri Umesh Kumar Pandey, pending with Disciplinary Authority/Director (HR), Delhi Transco Limited (a Government of NCT of Delhi Undertaking) from 2012.2024 & (ii) Non-disposal of Appeal for replacement of Presenting Officer (PO), Shri Bharat Tiwari, Sr. Manager (T), pending with Appellate Authority, i.e. Hon'ble Chairman and Managing Director, Delhi Transco Limited.

2. Shri Dharm Singh Meena has mentioned in his representation that he was suspended on 13.02.2024 without any advisory letter issued by controlling authorities for the works carried out during the period from 08.11.2021 to 29.11.2021, for so called material misappropriation amounting Rs. 38,14,130/-

only, without any numerical calculation and supporting documental evidence. He has further stated that the Vigilance Department of Delhi Transco Limited, framed false charges of embezzlement of material against him, however, the same material was present at site as recorded in charge sheet, which has been endorsed by Disciplinary Authority under imputation of Article of Charges.

3. In the matter, Commission issued Notice dated 20.02.2025 to the CMD, Delhi Transco Limited, to give reply within 15 days. Non-receipt of any report from the concerned authority in the matter, the sitting/hearing was scheduled on 17.04.2025 by the Commission. However, the concerned authority did not appear.

3.1 In the matter, the Commission fixed a further sitting on 16.05.2025 with the CMD, DTL. Accordingly, a sitting notice had been issued.

4. GM (HR), Delhi Transco Limited and the petitioner were present during the sitting held on 16.05.2025. The matter was heard in details.

5. After hearing the both parties, the Commission recommended the following:

1. ***The Delhi Transco Limited (DTL) may submit the copies of letters sent to Central Vigilance Commission (CVC) for First Stage Advice (FSA), on which basis, CVC issued the same.***
2. ***The Delhi Transco Limited (DTL) may withdraw FIR for missing HTLS Conductor drum, as the said conductor was not stolen and same was available at site and utilised on 220 kV Bamnauli-DIAL transmission line by DTL. The Authority is advised to submit the status report to Commission.***
3. ***The Commission is in the agreement of the plea of the Delhi Transco Limited for not changing the Inquiry Officer and Presenting Officer as the said officers are also conducting the inquiry of three other officials as co-accused in the case with Shri Dharam Singh Meena.***
4. ***The Delhi Transco Limited (DTL) is advised to ask the Inquiry Officer, Shri Umesh Kumar Pandey, to conclude the departmental Inquiry against Shri Dharm Singh Meena, at the earliest and Authority is also advised to send Daily Order Sheet (DoS) of each hearing to Commission.***
5. ***The Action Taken Report on above points may be submitted within 30 days from receipt of the minutes.***
