Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Guguloth Ashok, JTO (BBM), BSNL, Ghatkesar, Telangana Telecom Circle regarding grant of 30% HRA to BSNL staff working at Ghatkesar station.

Shri Guguloth Ashok, JTO (BBM), BSNL, Ghatkesar, Telangana Telecom Circle, vide his petition dated 02.12.2024 has requested for intervention regarding grant of 30% HRA to BSNL staff working at Ghatkesar station, Medchal-Malkajgiri District, Telangana, on par with the employees of Railways and Department of Posts stationed at the same location. He has stated that while Ghatkesar has been converted into a Municipality and other Central Government departments provide 30% HRA to their employees there, BSNL continues to provide only 10% HRA. He has enclosed supporting documents from the South Central Railway and Department of Posts to substantiate his claim.

- 2. NCST vide notice dated 7.3.2025 has referred the matter to CGM, BSNL, Telangana Circle, Hyderabad for furnishing the facts and comments within 30 days from receipt of the notice.
- 3. BSNL Telangana Circle, Hyderabad vide letter No TT/SCT/NCST/2024-25/18 dated 25.3.2025 has informed that the issue was forwarded to AGM (Estt.), Establishment, BSNL, New Delhi vide letter dated 22.2.2025 for further necessary approval. Hence, NCST decided to discuss the issue with the concerned authority and petitioner on 8.5.2025. Accordingly, a sitting notice issued to all concerned on 23.4.2025.
- 4. The BSNL vide letter no. TT/SCT/NCST/2024-25/38 dated 30.4.2025 has furnished the facts and stated that since the subject matter is in the purview of BSNL, Corporate Office, New Delhi and CGMT Telangana Circle has no role, as of now.
- 5. In the sitting, the CGM, BSNL, Telangana and CLO, BSNL were present. But the petitioner was absent. The officers of BSNL informed that the issue relates with D/o Telecommunication.
- 6. After discussion with the officers of BSNL, the following recommendations were made and action taken thereon may be submit to NCST within 30 days from receipt of the minutes.
- The Corporate Office, BSNL, New Delhi may take up the matter with the concerned Department for granting of 30% HRA to the employees of BSNL at Ghatsekar Station at par with the other Departments of Central Government.
