Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Tejavath Prashanth Naik (Ex-Constable, TGSP) Mahabubabad District regarding harassment and termination from job.

Date of the Sitting: 09/05/2025,4:10 PM Participants in the Sitting: As per Annexure

Shri Tejavath Prashanth Naik, S/o Shankar, aged 27 years, a former Police Constable with TGSP 4th Battalion, Mamnoor, Warangal, vide his petition dated 25.07.2024 has requested the Commission to conduct a detailed enquiry regarding a false case registered against him. He states that on 15.08.2023, he was called by the Cl of Police, Rajesh (TS-NAB), and instructed to report for an enquiry related to his maternal uncle. Despite being on duty in Kothagudem, he was escorted by police officials to Hyderabad, where he was illegally arrested and detained by TS-NAB. The petitioner alleges that the police officers, including Rajesh and RaghavendraSwamy, falsely implicated him in a case under various sections of the NDPS Act and IPC, even though he was traveling from Kothagudem to Hyderabad at the time of the alleged incident. He claims that this false case led to his job termination without a proper enquiry, causing significant hardship to him and his family. The petitioner requests a thorough investigation into the matter and the actions of the officers involved to ensure justice.

- 2. In this matter a sitting was held on 06.01.2025, the following recommendations were made and minutes sent to all concerned on 21.1.2025 with request to submit the action taken report within 30 days from receipt of the minutes.
- The records of the relieving of the petitioner by the Greyhounds may be furnished to the TNAB and DCP South west zone to prove his innocence. Just because he is the relative of the accused Sri Vankudothu Veeranna does not prove his involvement in the Narcotics case."
- 3. Police Department, Govt. of Telangana vide letter no. 22/OW/ACP-GOL/2025 dated 27-01-2025 has furnished the facts and stated that the enquiry report reveals that the petitioner failed to cooperate with the investigation, ignored multiple summons and gave excuses for his non-appearance in the investigation related to Crime No. 248 of 2023. It further mentions that Naik was arrested on 17-08-2023 and produced before the Court and that his confessional statement was recorded. The report highlights that the petitioner was involved in obstructing the investigation, making false allegations and evading legal proceedings. The report concludes that the petitioner's allegations are false and baseless due to the lack of evidence and his non-cooperation with the enquiry. NCST decided to discuss the issue with the authority and the petitioner on 09.05.2025. Accordingly, a sitting notice was sent on 25.04.2025.
- Dy. Commissioner, South West Zone, Hyderabad vide letter dated 6.5.2025 has sought exemption and deputed Inspector of Police, Langer House PS, Hyderabad.
- 5. In the sitting, Inspector of Police, Langer House PS, Hyderabad and petitioner were present. There was no information from Director, Telangana Anti Narcotics Bureau, Hyderabad. The petitioner reiterated his earlier submission and stated that the investigation has not been conducted at Greyhounds organisation where he work. Inspector of Police, Langer House PS, Hyderabad reiterated the submissions made by Police Department vide letter dated 27.1.2025.
- 6. The petitioner informed that he was taken into custody from Kothagudem and his car is in Gudur. However it is falsely implicated that he is arrested along with his vehicle and Shri Veeranna on the same date in Nagole.
- After discussion with the Inspector of Police, Langer House PS, Hyderabad and petitioner, the following recommendations were made and action taken report may be submitted to NCST at the earliest from receipt of the minutes.

a. The contradictions necessisate a detailed unbiased enquiry. A detailed report of the same may be furnished.

b. Director, T-NAB and DCP, South west Zone Hyderabad may attend to the next scheduled date of hearing.
