Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad, in the case of Shri V. Srinivasa Rao, Secretary, Tribal Affairs Advisory Council of (I) Society, Hyderabad regarding denial R&R Benefits by the Spl. Collector L&A. Pulichinthala Project H.Q Narasaraopet -Palnadu District (Andhra Pradesh).

Shri V. Srinivasa Rao, Secretary, Tribal Affairs Advisory Council of (I) Society, Suryapet District, Telangana, vide his representation dated November 2023, has stated that the Special Collector, L&A, Pulichinthala Project, Palnadu District (Andhra Pradesh) has denied Rehabilitation and Resettlement (R&R) benefits to affected persons, despite multiple communications from the Special Commissioner R&R, Vijayawada. It is alleged that the matter has been pending for long at the Collector's office, and the petitioner has requested that the Hon'ble Chairman personally intervene and direct the Collector, Palnadu District, to take immediate action, as the affected tribals are suffering irreparable hardship due to the delay.

- 2. NCST vide notice dated 12.08.2024 sought facts and comments from the Collector and DM, Palnadu and Superintendent of Police, Palnadu within 15 days from receipt of the Notice.
- 3. The Collector & District Magistrate, Palnadu District vide letter no. REV02-MS0MISC/74/2024-SA(C1)-COLLPND dated 29.10.2024 has informed that as per the report of the Special Collector (LA), Dr. K.L. Rao Sagar (Pulichintala) Project, R&R benefits were not paid to any individual claiming to be family members of late Bhukya Ramsingh Naik, as no one was recorded in the Socio-Economic Survey (SES) nor was any Family Member Certificate submitted. The Commissioner (R&R) clarified that only dependents recorded in the SES are eligible for R&R benefits, and anyone not recorded or already compensated separately is ineligible. Based on this clarification, the claims for R&R benefits on behalf of Bhukya Ramsingh Naik were rejected.
- 4. The Superintendent of Police, Palnadu District vide letter no. 28/C2-SC,ST Petns/DCRB-PLND/2024 dated 05.02.2025 has informed that the matter regarding payment of R&R benefits to the family members of late Bhukya Ramsingh Naik was enquired into by the SDPO, Sattenapalli. The enquiry revealed that the family had migrated to Mangalikunta Thanda, Telangana, after their original village, Chityala Thanda, was submerged due to the Pulichinthala Project. Though Ramsingh Naik had seven sons and two daughters, disputes between him and his wife led the project authorities to reject R&R benefits. The issue was reported to the Commission and is currently under enquiry by revenue authorities. The police have stated that they cannot interfere, as the matter falls under the purview of the revenue department. Thereafter the petitioner requested for a hearing by letter dated 04.03.2025. Hence, NCST decided to discuss the issue with the authority and the petitioner on 24.05.2025 at Hyderabad. Accordingly, a Sitting Notice was sent on 19.05.2025.
- In the sitting, Special Collector, Palnadu, officer of concerned project ,SDPO, Sattenapali and other officers were present. The petitioner joined via Video Conference.
- 6. The authority informed that in SES Data no names are entered by Bhukya Ramsingh Naik though he is a literate and it appears that and there is a domestic dispute between the 2 wives of Ramsingh Naik and he wilfully has ignored it and signed in the SES Sheet. Further as the SES Gazette has already been published there is no scope for inclusion of the family members after the lapse of several years.
- 7. After hearing to the authority an petitioner it is recommended that the family may first settle the dispute among themselves and produce family members certificate and shares of each individual member to the Revenue Department for any pending action to be considered by the Revenue Department.
