## NATIONAL COMMISSION FOR SCHEDULED TRIBES NCST/SER-1977/TS/255/2025-RO-BHUV/RU-III

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Smt Vadithe Maruthi, ADE/Mech, BTPS/TGGENCO, Manuguru regarding her request for transfer on spouse ground.

Date of the Sitting: 05/05/2025, 06:30 PM Participants in the Sitting: As per Annexure

Smt Vadithe Maruthi, ADE/Mech, BTPS/TGGENCO, Manuguru, vide her petition dated 15.01.2025 has requested for intervention in her transfer from Bhadradri Thermal Power Station (BTPS), Manuguru to TGGENCO, Vidyut Soudha, Hyderabad under the "spouse case" and on humanitarian grounds. She has detailed her 18-year service history, mostly spent at remote power stations, making it difficult to manage her child's health and education and affecting her family life. Her husband is a Scientific Officer/F at NFC, Hyderabad, in a non-transferable post, and she has been applying for a transfer for the last 12 years without success. She seeks relief to be stationed in Hyderabad to reunite with her family and care for her child. Hence, do the justice.

- 2. NCST vide notice dated 13.02.2025 sought facts and comments from the CMD, TSGENCO within 30 days from receipt of the Notice.
- 3. TSGENCO vide letter no. Dir (HR) (CGM(Adm)/DS(Adm)/As(Adm)/PO/458/2019 dated 10.03.2025 has informed that Smt. V. Maruthi, ADE/Mech was transferred from Yadadri Thermal Power Station (YTPS) to Bhadradri Thermal Power Station (BTPS) based on a vigilance report dated 18.10.2023, citing that her presence was causing disturbance in the harmonious and disciplined atmosphere at YTPS. However, her current request for transfer from BTPS to VidyutSoudha on spouse grounds will be considered during the general transfer cycle, which usually takes place in April/May each year, as per the transfer policy. This was forwarded to the petitioner for information on 25.03.2025.
- 4. The petitioner has submitted a rejoinder dated 30.03.2025. In the said rejoinder, the petitioner categorically refuted the reply furnished by the concerned authority and prayed for justice, which was referred to TSGENCO on 16.04.2025. There was no response from TSGENCO hence NCST decided to discuss the issue with the authority and the petitioner on 05.05.2025. Accordingly, a sitting notice was sent on 21.04.2025.
- 5. In the sitting, the Director (HR) and CGM, TSGENCO were present on behalf of TSGENCO. The petitioner was also present. The petitioner reiterated her submission and requested for justice. The officer of TSGENCO has reiterated their earlier submission and assured that her case will be considered in this month.
- 6. The petitioner has informed that many of the employees are pursuing with the management and were able to secure deputations/ transfers to their desired place and some are getting the relaxations and she inspite of being working away from Headquarter was not given a chance.
- 7. The authority has informed that in 2023 the transfers are not made due to the report of one man commission of Dharmadikari and in 2024 due to Elections Model Code of Conduct . In 2025, by the end of May 2025, General transfers will be completed and those who are working in distant places will be given priority and the issue of transfer request of the petitioner is under consideration.
- 8. After discussion with Director (HR) and CGM, TSGENCO and petitioner, the following recommendations were made and action taken there on may be submitted to NCST within 30 days from receipt of the Minutes.
- The case of the petitioner for transfer to Hyderabad may be considered on priority basis as assured by the
  officers of TSGENCO in the sitting.
- The Travel Allowance and Special Leave may be reimbursed / granted in favour of the petitioner as per her entitlement by the TSGENCO.
- The women employees may be given priority to their desired place. The transfers may be completed by the end of the month.
