

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Rajeshwar Sabavath, resident of Gurramguda, Hyderabad regarding selective disbursement of one-time interest-free loans to certain members of the CMSTEI 2018 batch.

**Date of the Sitting: 05/05/2025, 03:20 PM**  
**Participants in the Sitting: As per Annexure**

Shri Rajeshwar Sabavath, resident of Gurramguda, Hyderabad, vide his petition dated 09.12.2024 has raised concerns regarding the selective provision of one-time interest-free loans to certain members of the CMSTEI 2018 batch. He alleged that while 43 members earlier and 7 members now are being considered for the benefit, several non-COVID-affected members, including himself and others, have been unfairly excluded despite their eligibility. He claimed that assessments by the Telangana Health Clinic were flawed and biased, and financial limits under Cash Credit for some members were not honored as per norms announced by the COO of TIHCL. He also alleged mismanagement, favoritism (particularly towards one Ramjilal), and collusion between TRICOR and the Health Clinic in the process. He urged the Commission to intervene and ensure fair treatment for all CMSTEI 2018 batch members and prevent misuse of public funds.

2. NCST vide notice dated 27.12.2024 sought facts and comments from the Secretary, Tribal Welfare Department, Gov of Telangana within 30 days from the Notice. The reply was not received, hence, NCST decided to discuss the issue with the authority and the petitioner on 05.05.2025. Hence a sitting notice was sent on 21.04.2025.

3. In the sitting, the Secretary, Tribal Welfare Department, Govt. of Telangana was present. But the petitioner was absent.

4. After discussion with the Secretary, Tribal Welfare Department, Govt. of Telangana, it was observed that no action is warranted on part of NCST as the Secretary, Tribal Welfare have submitted the necessary documents in support of due procedure adopted in the process and there is no alleged bias found.


5. Hence, it is recommended for the closure of the file.
