Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Dheeravath Jahangir of Lappanaik Thanda, Yadadri Bhuvanagiri District regarding incomplete compensation of his submerged land.

Date of the Sitting: 07/05/2025, 12:20 PM

Shri Dheeravath Jahangir of Lappanaik Thanda, Yadadri Bhuvanagiri District, vide his petition dated 9.9.2024 has represented that although he owns 2 acres of land under the submerged zone of Nrusimha Reservoir, the Revenue Department paid compensation for only 1.28 acres.

2. NCST vide notice dated 24.03.2025 sought facts and comments from the Collector and District Magistrate, Yadadri Bhuvanagiri within 10 days from receipt of the Notice. The reply was not received, hence, NCST decided to discuss the issue with the authority and the petitioner on 07.05.2025. Accordingly, a sitting notice was sent on 22.04.2025.

3. In the sitting, the District Collector and Magistrate, Yadadri Bhuvanagiri District was present. The petitioner was not present. The District Collector and Magistrate, Yadadri Bhuvanagiri District has submitted the facts mentioned in the letter no. G/1562/2025 dated 23.4.2025 and stated that the compensation of Rs.35.52 lakh has already been provided to the petitioner, as per rules as per the award passed on 5.8.2022 by the Land acquisition officer An extent of Ac 1.11 was omitted as the said extent is covered with roads for which compensation is not payable. Hence, no action was pending on part of Administration.

4. After discussion with the District Collector and Magistrate, Yadadri Bhuvanagiri District and petitioner, it was observed that there is no action warranted on part of NCST. Hence, the case may be treated as closed.
