Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri B.T. Nayak, Secretary, Tribal Affairs Advisory Council of (I) Society from Suryapet District, Telangana regarding intentional insult, cheating, and assault by Sri. Balsunuri Rajumohan Reddy.

Shri B.T. Navak, Secretary, Tribal Affairs Advisory Council of (I) Society, Survapet District (Telangana) vide representation dated 04.12.2024 has forwarded the petition of Smt. Gugulothu Renuka. The petitioner, Smt. Gugulothu Renuka, resident of Yerragattu Thanda, Mellacheruvu Mandal, Suryapet District has alleged intentional insult, cheating and assault by Sri. Balsunuri Rajumohan Reddy. The representation was submitted to the Station House Officer, Mellacheruvu Police Station, Suryapet District, but no action has been taken so far. The petitioner has requested a detailed inquiry and urged that necessary action be taken by the Superintendent of Police and the Collector of Suryapet District, Telangana.

- NCST vide notice dated 06.01.2025 sought facts and comments from the Superintendent of Police, Survapet within 30 days from receipt of the Notice.
- The Superintendent of Police, Survapet District vide letter no. 03/C1-NC for STs/ DCRB-SRPT/2025 dated 13.03.2025 has informed that Smt Renuka and her husband had loaned a total of Rs.4,50,000 to Raja Mohan Reddy, but due to losses in his real estate business, he failed to repay the amount. The petitioners attempted to recover the loan through various means, including protests and filing a false complaint involving Smt. B. Shobha Rani, claiming she took Rs.5,00,000 to regularize Renuka's job as an ANM. However, the petitioner could not provide any evidence to support this claim. The matter regarding the loan is pending before the Hon'ble Senior Civil Judge Court at Huzurnagar vide IP No. 05/2024. Hence no further action is necessary as the case is sub judice. decided to discuss the issue with the authority and the petitioner on 09.05.2025. Accordingly, a sitting notice was sent on 25.04.2025.
- In the sitting, SDPO, Kodad was present on behalf of Supdt. of Police, Suryapet. The petitioner was not present. The SDPO, Kodad has reiterated the facts submitted by Police Department, Suryapet on 13.3.2025 and stated that the case is sub judice.
- After discussion with the SDPO, Kodad, it was observed that there is no action warranted on part of NCST. Hence, the case may be closed.
